SENATE BILL DRS15226-MH-33A

Short Title: Greater Accountability for Boards/Commissions. (Public)

Sponsors: Senators Daniel, Rabon, and Berger (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO INCREASE THE ACCOUNTABILITY OF PUBLIC BOARDS AND  
3 COMMISSIONS TO THE CITIZENS OF NORTH CAROLINA BY CHANGING THE  
4 APPOINTMENT STRUCTURE OF THOSE BOARDS AND COMMISSIONS.

5 The General Assembly of North Carolina enacts:

7 **PART I. UTILITIES COMMISSION**

8 **SECTION 1.(a)** The North Carolina Utilities Commission created under G.S. 62-10  
9 is transferred to the Department of State Treasurer. This transfer has all of the elements of a Type  
10 II transfer, as described in G.S. 143A-6. The Commission shall be administratively located within  
11 the Department of State Treasurer but shall exercise all its prescribed statutory powers  
12 independently of the Department of State Treasurer.

13 **SECTION 1.(b)** G.S. 62-10 reads as rewritten:

14 "**§ 62-10. Number; appointment; terms; qualifications; chairman; vacancies;**  
15 **compensation; other employment prohibited.**

16 (a) The North Carolina Utilities Commission shall consist of ~~seven commissioners who~~  
17 ~~shall be nine commissioners who shall be appointed as follows: four by the Governor, two by the~~  
18 General Assembly, upon recommendation of the Speaker of the House of Representatives in  
19 accordance with G.S. 120-121, two by the General Assembly, upon recommendation of the  
20 President Pro Tempore of the Senate in accordance with G.S. 120-121, and one by the State  
21 Treasurer. Each commissioner shall serve for a term of six years commencing on July 1 of the  
22 year in which the predecessor term expired and ending on July 1 of the sixth year thereafter.  
23 Commissioners appointed by the Governor and State Treasurer are subject to confirmation by  
24 the General Assembly by joint resolution. The names of commissioners to be appointed by the  
25 Governor and State Treasurer shall be submitted by the Governor and State Treasurer to the  
26 General Assembly for confirmation by the General Assembly on or before May 1, of the year in  
27 which the terms for which the appointments are to be made are to expire. Upon failure of the  
28 Governor or State Treasurer to submit names as herein provided, the Lieutenant Governor  
29 President Pro Tempore and Speaker of the House jointly shall submit the names of a like number  
30 of commissioners to the General Assembly on or before May 15 of the same year for confirmation  
31 by the General Assembly. Regardless of the way in which names of commissioners are submitted,  
32 confirmation of commissioners must be accomplished prior to adjournment of the then current  
33 session of the General Assembly. This subsection shall be subject to the provisions of subsection  
34 (c) of this section.

35 (b) ~~The terms of the commissioners now serving shall expire at the conclusion of the term~~  
36 ~~for which they were appointed which shall remain as before with two regular eight-year terms~~



1 expiring on July 1 of each fourth year after July 1, 1965, and the fifth term expiring on July 1 of  
2 each eighth year after July 1, 1963. The terms of office of utilities commissioners thereafter shall  
3 be six years commencing on July 1 of the year in which the predecessor terms expired, and ending  
4 on July 1 of the sixth year thereafter.

5 (c) ~~In order to increase the number of commissioners to seven, the names of two~~  
6 ~~additional commissioners shall be submitted to the General Assembly on or before May 27, 1975,~~  
7 ~~for confirmation by the General Assembly as provided in G.S. 62-10(a). The commissioners so~~  
8 ~~appointed and confirmed shall serve new terms commencing on July 1, 1975, one of which shall~~  
9 ~~be for a period of two years (with the immediate successor serving for a period of six years), and~~  
10 ~~one of which shall be for a period of two years.~~

11 ~~Thereafter, the terms of office of the additional commissioners shall be for six years as~~  
12 ~~provided in G.S. 62-10(b).~~

13 (d) A commissioner in office shall continue to serve until his successor is duly confirmed  
14 and qualified but such holdover shall not affect the expiration date of such succeeding term.

15 (e) On July 1, 1965, and every ~~four~~three years thereafter, one of the commissioners shall  
16 be designated by the Governor to serve as chairman of the Commission for the succeeding ~~four~~  
17 three years and until his successor is duly confirmed and qualifies. Upon death or resignation of  
18 the commissioner appointed as chairman, the Governor shall designate the chairman from the  
19 remaining commissioners and appoint a successor as hereinafter provided to fill the vacancy on  
20 the Commission.

21 (f) In case of death, incapacity, resignation or vacancy for any other reason in the office  
22 of any commissioner appointed by the Governor or State Treasurer prior to the expiration of his  
23 the commissioner's term of office, the name of his successor shall be submitted by the Governor  
24 within four weeks after the vacancy arises to the General Assembly for confirmation by the  
25 General Assembly. the name of the successor shall be submitted to the General Assembly by the  
26 appointing authority within four weeks after the vacancy arises for confirmation by the General  
27 Assembly. As used in this section, the term "appointing authority" means the Governor in the  
28 case of commissioners appointed by the Governor and the State Treasurer in the case of  
29 commissioners appointed by the State Treasurer. Upon failure of the Governor or State Treasurer  
30 to submit the name of the successor, the Lieutenant Governor-President Pro Tempore and Speaker  
31 of the House jointly shall submit the name of a successor to the General Assembly within six  
32 weeks after the vacancy arises. Regardless of the way in which names of commissioners are  
33 submitted, confirmation of commissioners must be accomplished prior to the adjournment of the  
34 then current session of the General Assembly. In case of death, incapacity, resignation, or  
35 vacancy for any other reason in the office of any commissioner appointed by the General  
36 Assembly prior to the expiration of the commissioner's term of office, the vacancy shall be filled  
37 as provided in G.S. 120-122.

38 (g) If a vacancy arises or exists pursuant to either subsection (a) ~~or (e)~~ or (f) of this section  
39 when the General Assembly is not in session, and the appointment is deemed urgent by the  
40 Governor, the commissioner may be appointed and serve on an interim basis pending  
41 confirmation by the General Assembly; provided, however, no person may be appointed to serve  
42 on an interim basis pending confirmation by the General Assembly if the person was subject to  
43 but not confirmed by the General Assembly within the preceding four years. The limitation on  
44 appointment contained in this subsection includes, among other things, unfavorable action on a  
45 joint resolution for confirmation, such as the resolution failing on any reading in either chamber  
46 of the General Assembly, and failure to ratify a joint resolution for confirmation prior to  
47 adjournment of the then current session of the General Assembly.

48 ...."

49 **SECTION 1.(c)** In order to increase the number of commissioners to nine, two  
50 additional commissioners shall be appointed to serve an initial term of four years as follows: one  
51 by the General Assembly, upon recommendation of the Speaker of the House of Representatives

1 in accordance with G.S. 120-121, whose term shall commence July 1, 2023, and expire June 30,  
 2 2027, and one by the General Assembly, upon recommendation of the President Pro Tempore of  
 3 Senate in accordance with G.S. 120-121, whose term shall commence July 1, 2023, and expire  
 4 June 30, 2027. Upon the expiration of the initial terms described in this subsection, the additional  
 5 commissioners appointed shall each serve a term of six years as provided in G.S. 62-10(a), as  
 6 amended in Section 1(b) of this act.

7 **SECTION 1.(d)** The terms of the commissioners now serving shall expire at the  
 8 conclusion of the term for which they were appointed. Upon the expiration of the terms of the  
 9 commissioners now serving, appointments to the Commission shall be made as follows:

- 10 (1) For the three terms expiring June 30, 2023, one commissioner shall be  
 11 appointed by the Governor, one by the General Assembly, upon the  
 12 recommendation of the Speaker of the House of Representatives in  
 13 accordance with G.S. 120-121, and one by the General Assembly, upon  
 14 recommendation of the President Pro Tempore of the Senate in accordance  
 15 with G.S. 120-121.  
 16 (2) For the three terms expiring June 30, 2025, two commissioners shall be  
 17 appointed by the Governor and one by the State Treasurer.  
 18 (3) For the term expiring June 30, 2027, one commissioner shall be appointed by  
 19 the Governor.

20 **SECTION 1.(e)** G.S. 143B-433 reads as rewritten:

21 "**§ 143B-433. Department of Commerce – organization.**

22 The Department of Commerce shall be organized to include:

- 23 (1) The following agencies:  
 24 a. Repealed by Session Laws 2014-100, s. 15.2A(c), effective October 1,  
 25 2014.  
 26 ~~b. The North Carolina Utilities Commission.~~

 29 **PART II. ECONOMIC INVESTMENT COMMITTEE**

30 **SECTION 2.1.(a)** G.S. 143B-437.54 reads as rewritten:

31 "**§ 143B-437.54. Economic Investment Committee established.**

32 (a) Membership. – The Economic Investment Committee is established. The Committee  
 33 consists of the following members:

- 34 (1) The Secretary of Commerce.  
 35 (2) The Secretary of Revenue.  
 36 (3) The Director of the Office of State Budget and Management.  
 37 (4) One member appointed by the General Assembly upon the recommendation  
 38 of the Speaker of the House of Representatives.  
 39 (5) One member appointed by the General Assembly upon the recommendation  
 40 of the President Pro Tempore of the Senate.  
 41 (6) The Speaker of the House of Representatives or a designee of the Speaker.  
 42 (7) The President Pro Tempore of the Senate or a designee of the President Pro  
 43 Tempore.

44 ~~The members of the Committee appointed by the General Assembly may not be members of~~  
 45 ~~the General Assembly.~~ The members of the Committee appointed by the General Assembly serve  
 46 two-year terms that begin upon appointment. The other members, who are ex officio members  
 47 or designees of those members, shall serve until they are no longer in office or are replaced with  
 48 another designee.

49 (b) Decision Required. – The Committee may act only upon a decision of ~~three of its five~~  
 50 a majority of its members.

51 ...."

1           **SECTION 2.1.(b)** G.S. 120-123(76) is repealed.

2           **SECTION 2.1.(c)** This section is effective when it becomes law.

4   **PART III. ENVIRONMENTAL MANAGEMENT COMMISSION**

5           **SECTION 3.1.(a)** G.S. 143B-283 reads as rewritten:

6   "**§ 143B-283. Environmental Management Commission – members; selection; removal;**  
7   **compensation; quorum; services.**

8       (a) Repealed by Session Laws 2013-360, s. 14.23(a), effective July 1, 2013.

9       (a1) Composition. – The Environmental Management Commission shall consist of 15  
10 members as follows:

11           (1) One appointed by the Governor who shall be a licensed physician.

12           (2) One appointed by the Governor who shall at the time of appointment have  
13 special training or scientific expertise in hydrology, water pollution control,  
14 or the effects of water pollution.

15           (3) One appointed by the Governor who shall at the time of appointment have  
16 special training or scientific expertise in hydrology, water pollution control,  
17 or the effects of water pollution.

18           (4) One appointed by the Governor who shall at the time of appointment have  
19 special training or scientific expertise in air pollution control or the effects of  
20 air pollution.

21           (5) One appointed by the ~~Governor~~ Commissioner of Agriculture who shall at the  
22 time of appointment be actively connected with or have had experience in  
23 agriculture.

24           (6) One appointed by the Governor who shall at the time of appointment have  
25 special training and scientific expertise in freshwater, estuarine, marine  
26 biological, or ecological sciences or be actively connected with or have had  
27 experience in the fish and wildlife conservation activities of the State.

28           (7) One appointed by the Governor who shall at the time of appointment be  
29 actively employed by, or recently retired from, an industrial manufacturing  
30 facility and shall be knowledgeable in the field of industrial pollution control.

31           (8) One appointed by the Governor who shall at the time of appointment be a  
32 licensed engineer with specialized training and experience in water supply or  
33 water or air pollution control.

34           (9) One appointed by the ~~Governor~~ Commissioner of Agriculture who shall serve  
35 at large.

36           (10) One appointed by the General Assembly upon recommendation of the Speaker  
37 of the House of Representatives in accordance with G.S. 120-121 who shall  
38 serve at large.

39           (11) One appointed by the General Assembly upon recommendation of the Speaker  
40 of the House of Representatives in accordance with G.S. 120-121 who shall  
41 serve at large.

42           (12) One appointed by the General Assembly upon recommendation of the Speaker  
43 of the House of Representatives in accordance with G.S. 120-121 who shall  
44 serve at large.

45           (13) One appointed by the General Assembly upon recommendation of the  
46 President Pro Tempore of the Senate in accordance with G.S. 120-121 who  
47 shall serve at large.

48           (14) One appointed by the General Assembly upon recommendation of the  
49 President Pro Tempore of the Senate in accordance with G.S. 120-121 who  
50 shall serve at large.

(15) One appointed by the General Assembly upon recommendation of the President Pro Tempore of the Senate in accordance with G.S. 120-121 who shall serve at large.

(b) Filling of Vacancies. – Any appointment to fill a vacancy on the Commission created by the resignation, dismissal, death or disability of a member shall be for the balance of the unexpired term. The Governor may reappoint a member of the Commission to an additional term if, at the time of the reappointment, the member qualifies for membership on the Commission under ~~subdivisions (1) through (9)~~ subdivision (1), (2), (3), (4), (6), (7), or (8) of subsection (a1) of this section. The Commissioner may reappoint a member of the Commission to an additional term if, at the time of the reappointment, the member qualifies for membership on the Commission under subdivision (5) or (9) of subsection (a1) of this section. Appointments by the General Assembly shall be made in accordance with G.S. 120-121, and vacancies in those appointments shall be filled in accordance with G.S. 120-122.

~~(b1) The Governor shall have the power to~~ Removal of Members. – Each appointing authority may remove any member of the Commission appointed by that appointing authority from office for misfeasance, malfeasance, or nonfeasance in accordance with the provisions of G.S. 143B-13 of the Executive Organization Act of 1973. ~~nonfeasance.~~

(b2) Per Diem and Expenses. – The members of the Commission shall receive per diem and necessary travel and subsistence expenses in accordance with the provisions of G.S. 138-5.

(b3) Quorum. – A majority of the Commission shall constitute a quorum for the transaction of business.

(b4) Administrative Support. – All clerical and other services required by the Commission shall be supplied by the Secretary of Environmental Quality.

(c) Repealed by Session Laws 2015-9, s. 1.2, effective April 27, 2015.

(c1) Ethics. – All members of the Commission are covered persons for the purposes of Chapter 138A of the General Statutes, the State Government Ethics Act. As covered persons, members of the Commission shall comply with the applicable requirements of the State Government Ethics Act, including mandatory training, the public disclosure of economic interests, and ethical standards for covered persons. Members of the Commission shall comply with the provisions of the State Government Ethics Act to avoid conflicts of interest. The Governor may require additional disclosure of potential conflicts of interest by members. The Governor may promulgate criteria regarding conflicts of interest and disclosure thereof for determining the eligibility of persons under this subsection, giving due regard to the requirements of federal legislation, and, for this purpose, may promulgate rules, regulations, or guidelines in conformance with those established by any federal agency interpreting and applying provisions of federal law.

(d) Repealed by Session Laws 2013-360, s. 14.23(a), effective July 1, 2013.

(e) Terms. – Members of the Commission shall serve terms of four years."

**SECTION 3.1.(b)** G.S. 143B-284 reads as rewritten:

**"§ 143B-284. Environmental Management Commission – officers.**

The Environmental Management Commission shall have a chairman and a ~~vice chairman.~~ ~~The chairman shall be designated by the Governor from among the members of the Commission to serve as chairman at the pleasure of the Governor. The vice chairman shall be vice-chairman~~ elected by and from the members of the Commission and shall serve for a term of two years or until the expiration of ~~his~~ their regularly appointed ~~term~~ terms whichever comes first."

#### **PART IV. COMMISSION FOR PUBLIC HEALTH**

**SECTION 4.1.(a)** G.S. 130A-30 reads as rewritten:

**"§ 130A-30. Commission for Public Health – Members; selection; quorum; compensation.**

(a) Composition. – The Commission for Public Health shall consist of the following 13 members, four of whom shall be elected members:

- 1           (1) Four elected by the North Carolina Medical Society and nine of whom shall  
 2           be Society.  
 3           (2) Four at-large members appointed by the General Assembly in accordance with  
 4           G.S. 120-121, two upon the recommendation of the President Pro Tempore of  
 5           the Senate and two upon the recommendation of the Speaker of the House of  
 6           Representatives.  
 7           (3) Five appointed by the Governor.

8           (b) Qualifications of Members Appointed by the Governor. – One of the members  
 9 appointed by the Governor shall be a licensed pharmacist, ~~one a registered engineer experienced~~  
 10 ~~in sanitary engineering or a soil scientist,~~ one a licensed veterinarian, one a licensed optometrist,  
 11 one a licensed dentist, and one a registered nurse. ~~The initial members of the Commission shall~~  
 12 ~~be the members of the State Board of Health who shall serve for a period equal to the remainder~~  
 13 ~~of their current terms on the State Board of Health, three of whose appointments expire May 1,~~  
 14 ~~1973, and two of whose appointments expire May 1, 1975.~~

15           (b1) Length of Terms. – Members appointed to the Commission shall serve for a term of  
 16 four years. At the end of the respective terms of office of ~~initial~~ members of the Commission,  
 17 their successors shall be appointed for terms of four years ~~and until their successors are appointed~~  
 18 ~~and qualify.~~ years. Any appointment to fill a vacancy on the Commission created by the  
 19 resignation, dismissal, death, or disability of a member shall be filled by the appointing authority  
 20 for the balance of the unexpired term. As used in this section, the term "appointing authority"  
 21 means the North Carolina Medical Society in the case of members elected by the Medical  
 22 Society, the General Assembly in the case of members appointed by the General Assembly, and  
 23 the Governor in the case of members appointed by the Governor.

24           (c) ~~The North Carolina Medical Society shall have the right to remove any member~~  
 25 ~~elected by it for misfeasance, malfeasance, or nonfeasance, and the Governor shall have the right~~  
 26 ~~to~~ Removal of Members. – Each appointing authority may remove any member appointed by  
 27 him that appointing authority for misfeasance, malfeasance, or nonfeasance in accordance with  
 28 the provisions of G.S. 143B-13. nonfeasance.

29           (c1) Filling of Vacancies. – Vacancies on said the Commission among the membership  
 30 elected by the North Carolina Medical Society shall be filled by the executive committee of the  
 31 Medical Society until the next meeting of the Medical Society, when the Medical Society shall  
 32 fill the vacancy for the unexpired term. Vacancies on said the Commission among the  
 33 membership appointed by the General Assembly shall be filled by the General Assembly as  
 34 provided in subdivision (a)(2) of this section for the unexpired term. Vacancies on the  
 35 Commission among the membership appointed by the Governor shall be filled by the Governor  
 36 for the unexpired term.

37           (d) Quorum. – A majority of the members of the Commission ~~shall constitute~~ constitutes  
 38 a quorum for the transaction of business.

39           (e) Per Diem and Expenses. – The members of the Commission shall receive per diem  
 40 and necessary traveling and subsistence expenses in accordance with the provisions of  
 41 G.S. 138-5."

42           **SECTION 4.1.(b)** To minimize the impact of this section on the work of the  
 43 Commission for Public Health, the Governor shall not appoint successors to the four members  
 44 of the Commission whose terms expire on April 30, 2023. Instead, the General Assembly shall  
 45 appoint four at-large members to the Commission in accordance with G.S. 130A-30(a)(2), as  
 46 enacted by this section, to succeed the four members appointed by the Governor whose terms  
 47 expire on April 30, 2023.

48           **SECTION 4.1.(c)** This section is effective when it becomes law.

## 50 PART V. BOARD OF TRANSPORTATION

51           **SECTION 5.1.(a)** G.S. 143B-350 reads as rewritten:

1 **"§ 143B-350. Board of Transportation – organization; powers and duties, etc.**

2 (a) Board of Transportation. – There is hereby created a Board of Transportation. The  
3 Board shall carry out its duties consistent with the needs of the State as a whole. The diversity  
4 and size of the State require that regional differences be considered by Board members as they  
5 develop transportation policy and projects for the benefit of the citizens of the State. The Board  
6 shall carry out its duties consistent with the fiduciary responsibility to ensure the solvency of the  
7 State Highway Fund and Highway Trust Fund.

8 (b) ~~Membership of the Board.~~—

9 (1) ~~Number, appointment.~~—~~The Board of Transportation shall have 20 voting~~  
10 ~~members. Voting members shall be appointed as provided in subdivisions (2)~~  
11 ~~and (3) of this subsection for terms of office beginning July 31 of the year of~~  
12 ~~initial appointment, and every four years thereafter. Fourteen of the members~~  
13 ~~shall be division members appointed by the Governor. Six members shall be~~  
14 ~~at large members appointed by the General Assembly, three upon~~  
15 ~~recommendation of the President Pro Tempore of the Senate and three upon~~  
16 ~~recommendation of the Speaker of the House of Representatives. The~~  
17 ~~Secretary of Transportation shall serve as an ex officio nonvoting member of~~  
18 ~~the Board. No more than three members of the Board may reside in the same~~  
19 ~~highway division.~~

20 (2) ~~Division members.~~—~~One member shall be appointed from and be a resident~~  
21 ~~of each of the 14 highway divisions. Division members shall regularly consult~~  
22 ~~with and consider the views of local government units and Transportation~~  
23 ~~Advisory Committees in the region they represent. The Governor shall appoint~~  
24 ~~one member from each of the fourteen divisions as follows:~~

25 a. ~~Division 1, beginning in 2020.~~

26 b. ~~Division 2, beginning in 2022.~~

27 c. ~~Division 3, beginning in 2020.~~

28 d. ~~Division 4, beginning in 2022.~~

1 Composition. – The Board of Transportation shall be composed as follows:

- 2 (1) The Board shall consist of 20 voting members. The General Assembly shall  
 3 appoint 14 voting members from which seven voting members shall be  
 4 appointed upon the recommendation of the President Pro Tempore of the  
 5 Senate in accordance with G.S. 120-121 and seven voting members shall be  
 6 appointed upon the recommendation of the Speaker of the House of  
 7 Representatives in accordance with G.S. 120-121. The Governor shall appoint  
 8 six at-large voting members. Each highway division shall have at least one  
 9 voting member that is a resident of that highway division, however, no more  
 10 than three voting members may reside in the same highway division.  
 11 (2) The Secretary of Transportation shall serve as an ex officio nonvoting member  
 12 of the Board.  
 13 (3) All appointments shall be for a term of four years and terms shall expire on  
 14 June 30 of the year of expiration.

15 ~~(e) Staggered Terms. – The terms of all Board members serving on the Board prior to~~  
 16 ~~July 31, 2020, shall expire on July 30, 2020. A new board of 20 voting members shall be~~  
 17 ~~appointed with terms beginning on July 31, 2020.~~

19 ~~(e) Organization and Meetings of the Board. – Within 30 days after July 31, 2020, the~~  
 20 ~~Governor shall call the Board into session. The Governor~~ The Board shall select a chair from  
 21 among the Board's membership for a two-year term. The Board shall select a vice-chair from  
 22 among its membership for a two-year term. The Governor ~~Board~~ may select a chair for one  
 23 additional two-year term. The Board may select a vice-chair for one additional two-year term.

- 38 (12) One appointed by the General Assembly upon recommendation of the  
39 President Pro Tempore of the Senate in accordance with G.S. 120-121 who

- 42 (13) One appointed by the General Assembly upon recommendation of the

20 described in subsection (c1) of this section. The Governor may promulgate criteria regarding  
21 conflicts of interest and disclosure thereof for determining the eligibility of persons described in  
22 subsection (c1) of this section.

29 (g) Terms. – The members shall serve staggered terms of office of four years. At the

32 (h) Vacancies. – In the event of a vacancy arising otherwise than by expiration of term,  
33 the appointing authority shall appoint a successor of like qualification as specified in subsection

37 vice-chairman shall be elected by and from the members of the Commission and shall serve for  
38 a term of two years or until the expiration of the vice-chairman's ~~their~~ regularly appointed

40 (j) Compensation. – The members of the Commission shall receive per diem and  
41 necessary travel and subsistence expenses in accordance with the provisions of G.S. 138-5.

43 (l) Attendance. – Regular attendance at Commission meetings is a duty of each member.

47 **SECTION 6.1.(b)** To minimize the impact of this section on the work of the

**PART VII. WILDLIFE RESOURCES COMMISSION**

**SECTION 7.1.(a)** G.S. 143-241 reads as rewritten:

The members of the North Carolina Wildlife Resources Commission shall be appointed as follows:

The Governor shall appoint one member each from the first, fourth, and seventh wildlife districts to serve six-year terms;

The Governor shall appoint one member each from the second, fifth, and eighth wildlife districts to serve two-year terms;

The Governor shall appoint one member each from the third, sixth, and ninth wildlife districts to serve four-year terms;

The Governor shall also appoint two at-large members to serve four-year terms.

The General Assembly shall appoint ~~eight~~ 10 members of the Commission to serve two-year terms, ~~four~~ five upon the recommendation of the Speaker of the ~~House~~, ~~four~~ House, and ~~five~~ upon the recommendation of the President Pro Tempore of the Senate, in accordance with G.S. 120-121. Of the members appointed upon the recommendation of the Speaker of the House and upon the recommendation of the President Pro Tempore of the Senate, at least one of each shall be a member of the political party to which the largest minority of the members of the General Assembly belongs.

Thereafter as the terms of office of the members of the Commission appointed by the Governor from the several wildlife districts expire, their successors shall be appointed for terms of six years each. As the terms of office of the members of the Commission appointed by the General Assembly expire, their successors shall be appointed for terms of two years each. All members appointed by the Governor serve at the pleasure of the Governor that appointed them and they may be removed by that Governor at any time. A successor to the appointing Governor may remove a Commission member only for cause as provided in G.S. 143B-13. Members appointed by the General Assembly serve at the pleasure of that body and may be removed by law at any time. In the event that a Commission member is removed, the member appointed to replace the removed member shall serve only for the unexpired term of the removed member."

**SECTION 7.1.(b)** G.S. 143-241, as amended by subsection (a) of this section, reads as rewritten:

**"§ 143-241. Appointment and terms of office of Commission members; filling of vacancies.**

The members of the North Carolina Wildlife Resources Commission shall be appointed as follows:

The Governor shall appoint one member each from the first, fourth, and seventh wildlife districts to serve six-year terms;

The Governor shall appoint one member each from the second, fifth, and eighth wildlife districts to serve two-year terms;

The Governor shall appoint one member each from the third, sixth, and ninth wildlife districts to serve four-year terms;

The Governor shall ~~also appoint two at-large members~~ one at-large member and the Commissioner of Agriculture shall appoint one at-large member to serve four-year terms.

The General Assembly shall appoint 10 members of the Commission to serve two-year terms, five upon the recommendation of the Speaker of the House, and five upon the recommendation of the President Pro Tempore of the Senate, in accordance with G.S. 120-121. Of the members appointed upon the recommendation of the Speaker of the House and upon the recommendation of the President Pro Tempore of the Senate, at least one of each shall be a member of the political party to which the largest minority of the members of the General Assembly belongs.

Thereafter as the terms of office of the members of the Commission appointed by the Governor from the several wildlife districts expire, their successors shall be appointed for terms of six years each. As the terms of office of the members of the Commission appointed by the

1 General Assembly expire, their successors shall be appointed for terms of two years each. All  
2 members appointed by the Governor or by the Commissioner of Agriculture serve at the pleasure  
3 of the ~~Governor~~ authority that appointed them and they may be removed by that ~~Governor~~  
4 appointing authority at any time. A successor to the appointing ~~Governor~~ authority may remove  
5 a Commission member only for cause as provided in G.S. 143B-13. Members appointed by the  
6 General Assembly serve at the pleasure of that body and may be removed by law at any time. In  
7 the event that a Commission member is removed, the member appointed to replace the removed  
8 member shall serve only for the unexpired term of the removed member."

33 **SECTION 8.1.(b)** The appointee of the Governor replaced by the appointee of the  
34 State Treasurer because of the revision to G.S. 124-15 enacted in subsection (a) of this section  
35 shall be one of the appointees of the Governor with a term expiring in 2023. The Board of  
36 Directors shall determine which of these appointees will be replaced by the appointee of the State  
37 Treasurer.

38 **SECTION 8.1.(c)** This section becomes effective on the date that revisions to the  
39 Articles of Incorporation of a State-owned railroad to implement the changes in appointing  
40 authority made by this section are enacted by the Board of Directors of the State-owned railroad

d. All at-large positions shall serve four-year terms beginning November 1 of the year of appointment. At-large positions shall be filled by the appointment of persons from the business and professional public at large who have special competence in business management, hospital administration, health care delivery, or medical practice or who otherwise have demonstrated dedication to the improvement of health care in North Carolina, and who are neither members of the Board of Governors, members of the board of trustees of a constituent institution of The University of North Carolina, nor officers or employees of the State. No member may be appointed to more than two full four-year terms in succession, including members serving as of June 30, 2012. Any vacancy in an unexpired term shall be filled by the appointing authority for the balance of the term remaining-remainder of the unexpired term. Vacancies for members appointed by the General Assembly shall be filled as provided in G.S. 120-122.

**SECTION 9.1.(b)** The terms of office for all ex officio members of the board of directors of the University of North Carolina Health Care System repealed by this section shall expire July 1, 2023. All at-large members of the board of directors of the University of North Carolina Health Care System serving as of July 1, 2023, shall remain in office until their current term of appointment expires. Any vacancy occurring in a seat appointed by the board of directors expiring October 31, 2024, shall be filled by the General Assembly upon recommendation of the Speaker of the House of Representatives for the remainder of that term of office.

**SECTION 9.1.(c)** Notwithstanding the requirement for annual appointments by the General Assembly established by G.S. 116-37(b)(1)a1. and length of terms established by G.S. 116-37(b)(1)d., as enacted and amended by this section, the following appointments shall be made in 2023:

- (1) For a term beginning July 1, 2023, and ending October 31, 2027, one member shall be appointed by the General Assembly upon recommendation of the Speaker of the House of Representatives and one member shall be appointed by the General Assembly upon recommendation of the President Pro Tempore of the Senate. Members appointed to fill those terms of office in 2027 shall be appointed to four-year terms of office as provided in G.S. 116-37(b)(1)d. These members shall fill seats vacated by the prior ex officio members of the board.
- (2) For a term beginning July 1, 2023, and ending October 31, 2026, one member shall be appointed by the General Assembly upon recommendation of the Speaker of the House of Representatives and one member shall be appointed by the General Assembly upon recommendation of the President Pro Tempore of the Senate. Members appointed to fill those terms of office in 2026 shall be appointed to four-year terms of office as provided in G.S. 116-37(b)(1)d. These members shall fill seats vacated by the prior ex officio members of the board.

1 (3) For a term beginning October 1, 2023, and ending October 31, 2025, one  
2 member shall be appointed by the General Assembly upon recommendation  
3 of the President Pro Tempore of the Senate. The member appointed to fill that  
4 term of office in 2025 shall be appointed to a four-year term of office as  
5 provided in G.S. 116-37(b)(1)d. This member shall fill a position expiring in  
6 2023 held by a board of trustee appointment.

7 (4) For a term beginning October 1, 2023, and ending October 31, 2024, one  
8 member shall be appointed by the General Assembly upon recommendation

## 47 **PART X. MISCELLANEOUS**

48 **SECTION 10.1.** If any section or provision of this act is declared unconstitutional  
49 or invalid by the courts, it does not affect the validity of this act as a whole or any part other than  
50 the part so declared to be unconstitutional or invalid.
