A BILL TO BE ENTITLED

AN ACT TO ESTABLISH HOUSE DISTRICTS.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 120-2 is rewritten to read:

"§ 120-2. House apportionment specified.

(a) For the purpose of nominating and electing members of the North Carolina House of Representatives in 2002 and periodically thereafter; the State of North Carolina shall be divided into the following districts with each district electing one Representative, except that Districts 17, 28, 52, and 106 each elect two Representatives and except that District 29 elects three Representatives:
