March 20, 1989 1 A BILL TO BE ENTITLED 2 AN ACT TO ESTABLISH THE SMALL BUSINESS DEVELOPMENT COUNCIL. 3 The General Assembly of North Carolina enacts: Section 1. Chapter 147 of the General Statutes is amended by adding a new 4 5 article to read: "ARTICLE 4C. 6 "SMALL BUSINESS DEVELOPMENT COUNCIL. 7 8 "§ 147-54.25. Purpose. It is the purpose of this Article to establish the Small Business Development Council 9 to enhance the effectiveness of State-funded programs designed to stimulate small 10 business development in North Carolina by creating an environment that encourages 11 cooperation among State agencies that provide assistance to small businesses. 12 "§ 147-54.26. Small Business Development Council established. 13 There is established within the Department of the Secretary of State the Small 14 Business Development Council. The Small Business Development Council shall have 15 the following duties: 16 17 To develop methods to increase public awareness of State-funded (1) programs designed to stimulate small business development in North 18 19 Carolina. 20 To publish a list of State agencies that provide programs or assistance (2) 21 to small businesses. 22 To review new programs relating to small business assistance to (3) ensure that the programs are needed and are not currently being 23

provided by any member of the Council.

- 1 (b) The Secretary of State shall serve as chairman of the Small Business
  2 Development Council. The Secretary of Commerce shall serve as vice-chairman of the
  3 Council and shall preside at the meetings in the absence of the chairman.
  - The chairman shall have the following duties:
    - (1) To preside at all Small Business Council meetings.
    - (2) To schedule an adequate number of meetings to ensure the effectiveness of the Council.
    - (3) To provide the means for assuring input from the private sector.
    - (4) To request State agencies not named to the Council to provide information to the Council on programs being offered to assist small businesses.
    - (5) To ensure that agencies not named in subsection (a) but which meet the funding requirement in subsection (a) serve on the Small Business Development Council and to determine which agencies meet the criteria in cases in which membership is disputed.
    - (6) To present the Council's report to the General Assembly and the Governor annually. In order to perform this duty, the chairman may require members of the Small Business Development Council to furnish information needed to produce a complete report.
  - (c) The Council shall meet at least semiannually and may hold additional meetings at any time and place at the call of the chairman. A majority of the Council shall constitute a quorum for the transaction of business.
  - (d) State departments and agencies shall provide the Council any information and assistance it considers necessary. Professional staff and clerical staff shall be furnished to the Council by the Department of the Secretary of State."
  - Sec. 2. There is appropriated from the General Fund to the Department of the Secretary of State the sum of fifteen thousand dollars (\$15,000) for the 1989-90 fiscal year to be allocated for printing, postage, and distribution expenses of the Small Business Development Council and the sum of fifteen thousand dollars (\$15,000) for the 1990-91 fiscal year to be allocated for printing, postage, and distribution expenses of the Small Business Development Council.
  - Sec. 3. Section 1 of this act shall become effective October 1, 1989. The remainder of this act shall become effective July 1, 1989.
