A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO IMPLEMENT THE RECOMMENDATIONS OF THE TASK FORCE ON THE PREPARATION OF TEACHERS.

The General Assembly of North Carolina enacts:

Section 1. The State Board of Education and the Board of Governors of The University of North Carolina shall implement the objectives of the plan for the preparation of teachers as identified in "The Education of North Carolina Teachers" report and in the "Second Annual Report of the Joint Committee on Teacher Education of the Board of Governors of The University of North Carolina and the State Board of Education."

Sec. 2. There is appropriated from the General Fund to the Department of Public Education the sum of two million nine hundred sixty-six thousand dollars (\$2,966,000) for the 1989-90 fiscal year, and the sum of four million one hundred sixteen thousand dollars (\$4,116,000) for the 1990-91 fiscal year to be used by the State Board of Education to carry out the following program components as identified in the "Second Annual Report on the Joint Committee on Teacher Education of the Board of Governors of The University of North Carolina and the State Board of Education" :

5 Sec. 3. There is appropriated from the General Fund to the Board of
6 Governors of The University of North Carolina the sum of two million six hundred
7 sixty-one thousand eight hundred eighteen dollars (\$2,661,818) for the 1989-90 fiscal
8 year, and the sum of two million seven hundred thirty thousand six hundred twenty-six
9 dollars (\$2,730,626) for the 1990-91 fiscal year, to be used to carry out the following
10 program components as identified in the "Second Annual Report of the Joint Committee
11 on Teacher Education of the Board of Governors of The University of North Carolina
12 and the State Board of Education" :

26 improvement of the preparation of teachers as set forth in the report, "The Education of
27 North Carolina Teachers,"and in the "Second Annual Report on the Joint Committee on
28 Teacher Education of the Board of Governors of The University of North Carolina and
29 the State Board of Education."

30 Sec. 5. This act shall become effective July 1, 1989.
