A BILL TO BE ENTITLED

2 AN ACT TO ESTABLISH A CANCER CONTROL STUDY COMMISSION AND TO3 APPROPRIATE FUNDS.

4 Whereas, a total of 12,969 people died in 1989 and 13,198 people died in 5 1990 from cancer in North Carolina; and

6 Whereas, 14,000 people are predicted to die in 1992 from cancer in North 7 Carolina; and

8 Whereas, morbidity and disability from cancer are estimated to be responsible 9 for 10% of the total cost of disease in North Carolina and for lost productivity among 10 the work force, in addition to the personal loss, grief, and financial disruption 11 experienced by families; and

Whereas, 34% of annual cancer deaths in North Carolina are premature adult deaths occurring to persons between the ages of 20 and 64, equivalent to approximately 4,460 deaths per year or 12 deaths per day; and

Whereas, the National Cancer Institute has estimated that the mortality rate from cancer can be reduced by 50% through prevention, early detection, and prompt, appropriate treatment and follow-up; and

18 Whereas, a statewide Cancer Control Program has been legislatively 19 established to provide cancer prevention, detection, treatment, and education, but 20 unfortunately the resources available to the Program are limited relative to the needs for 21 cancer control efforts, and the Program has been forced to cease authorizing care by 22 physicians and hospitals before the end of the fiscal year in each of the last three years 23 due to depletion of funds; and

1	Whereas, it is estimated that 900,000 people in North Carolina have no health
2	insurance on any day; and
3	Whereas, various cancer control activities currently exist in several State
4	departments and institutions and in many non-State institutions in North Carolina; and
5	Whereas, the prevention and treatment of cancer require planned,
6	coordinated, well-funded and systematically implemented public and professional
7	educational efforts, state of the art information, and medical care availability to all
8	North Carolina residents; and
9	Whereas, the North Carolina Public Health System is responsible for public
10	health, but lacks the financial resources and the coordinating responsibilities to
11	undertake a comprehensive cancer control effort; and
12	Whereas, a comprehensive, well-financed, coordinated cancer control effort
13	can improve the health status of North Carolinians and can provide affordable economic
14	and social return to the State; Now, therefore,
15	The General Assembly of North Carolina enacts:
16	Section 1. The Cancer Control Study Commission is created. The

1 Sec. 4. The Commission shall submit a final report of its findings and 2 recommendations to the General Assembly by filing the report with the President Pro 3 Tempore of the Senate and the Speaker of the House of Representatives no later than 4 March 31, 1993. Upon filing its final report, the Commission shall terminate.

5 Sec. 5. The Commission, while in the discharge of official duties, may 6 exercise all the powers provided for under the provisions of G.S. 120-19, and G.S. 120-7 19.1 through G.S. 120-19.4. The Commission may meet at any time upon the joint call 8 of the cochairs. The Commission may meet in the Legislative Building or the 9 Legislative Office Building.

10 Sec. 6. Members of the Commission shall receive subsistence and travel 11 expenses at the rates set forth in G.S. 120-3.1, 138-5, and 138-6, as applicable.

12 Sec. 7. The Commission may contract for professional, clerical, or consultant 13 services as provided by G.S. 120-32.02, and may purchase or contract for the materials 14 and services it needs. The Legislative Services Commission, through the Legislative 15 Administrative Officer, shall assign professional staff to assist in the work of the 16 Commission. The House of Representatives' and the Senate's Supervisor of Clerks shall 17 assign clerical staff to the Commission, upon the direction of the Legislative Services 18 Commission. The expenses relating to clerical employees shall be borne by the 19 Commission. With the consent of the Secretary of the Department of Environment, 20 Health, and Natural Resources, staff employed by the Department or any of its divisions 21 may be assigned permanently or temporarily to assist the Commission or its staff.

22 Sec. 8. When a vacancy occurs in the membership of the Commission the 23 vacancy shall be filled by the same appointing officer who made the initial appointment.

Sec. 9. All State departments and agencies and local governments and their subdivisions shall furnish the Commission with any information in their possession or available to them.

27 Sec. 10. There is appropriated from the General Fund to the General 28 Assembly the sum of ten thousand dollars (\$10,000) for the 1992-93 fiscal year for the 29 expenses of the Commission.

Sec. 11. This act becomes effective July 1, 1992.
