1	A BILL TO BE ENTITLED
2	AN ACT TO IMPLEMENT A RECOMMENDATION OF THE GENERAL
3	STATUTES COMMISSION TO MAKE TECHNICAL AMENDMENTS
4	REGARDING THE RENUNCIATION OF PROPERTY.
5	The General Assembly of North Carolina enacts:
6	Section 1. G.S. 31B-3(b) reads as rewritten:
7	"(b) In the event that the property or interest renounced was created by
8	testamentary disposition, the devolution of the property or interest renounced shall be
9	governed by G.S. 31-42(a) and (b)-notwithstanding that in fact the renouncer has not
10	actually died before the testator."
11	Sec. 2. G.S. 31B-3 is amended by adding a new subsection to read:
12	"(c) In the event that the decedent dies intestate, or the ownership or succession to
13	property or to an interest is to be determined as though a decedent had died intestate,
14	and the renouncer has living issue who would have been entitled to an interest in the
15	property or interest if the renouncer had predeceased the decedent, then the property or
16	interest renounced shall be distributed to such issue, per stirpes. If the renouncer does
17	not have such issue, then the property or interest shall be distributed as though the
18	renouncer had predeceased the decedent."
19	Sec. 3. This act becomes effective October 1, 1993, and applies to any
20	renunciation made on or after that date.
