Section 1. G.S. 105-164.13 is amended by adding a new subdivision to read: "(29a) Sales to State agencies of works of art for a State building pursuant to Article 47A of Chapter 143 of the General Statutes. As used in this subdivision, the terms 'works of art' and 'State building' have the
