A BILL TO BE ENTITLED

2 AN ACT TO ALLOW SHAMPOOING BY UNLICENSED SHAMPOOERS IN 3 JONES AND LENOIR COUNTIES.

- 4 The General Assembly of North Carolina enacts:
 - Section 1. G.S. 88-1 reads as rewritten:

6 "§ 88-1. Practice of cosmetology regulated; permits for operation of cosmetic art 7 shops.

8 (a) On and after June 30, 1933, no person or combination of persons shall, for 9 pay or reward, either directly or indirectly, practice or attempt to practice cosmetic art as 10 hereinafter defined in the State of North Carolina without a certificate of registration, 11 either as a registered apprentice or as a registered 'cosmetologist,' issued pursuant to the 12 provisions of this Chapter by the State Board of Cosmetic Art Examiners hereinafter 13 established and, except as provided in G.S. 88-7.1; the practice of cosmetic art shall not 14 be performed outside of a licensed and regularly inspected beauty establishment.

The operator of a cosmetic art shop, beauty parlor or hairdressing 15 (b)establishment may employ unlicensed personnel to do shampooing only, where the 16 shampooing is done under the supervision of a registered cosmetologist. As used in this 17 paragraph, 'shampooing' includes only the application of shampoo to hair and the 18 removal of the shampoo from the hair, and does not include any arranging, dressing, 19 waving, marcelling or other treatment of hair. This paragraph does not apply to 20 barbershops. This paragraph shall not apply to the following counties: Guilford, Jones, 21 22 Lenoir, Mecklenburg, Onslow, Richmond, Sampson.

23 (c) On and after February 1, 1976, any person, firm or corporation, before 24 establishing or opening a cosmetic art shop not heretofore licensed by the State Board of

1 Cosmetic Art, shall make application to the Board, on forms to be furnished by the 2 Board, for a permit to operate a cosmetic art shop. The shop of such applicant shall be 3 inspected and approved by the State Board of Cosmetic Art by an agent designated for 4 such purpose by the Board before such cosmetic art shop shall be opened for business. It shall be unlawful to open a new cosmetic art shop for the practice of cosmetology 5 6 until such shop has been inspected, as heretofore required, and determined by the Board 7 to be in compliance with the requirements set forth in this Chapter. Upon the 8 determination by the Board that the applicant has complied with the requirements of this 9 Chapter, the Board shall issue to such applicant a permit to operate a cosmetic art shop. 10 A fee of twenty-five dollars (\$25.00) shall be paid to the Board for the inspection of a cosmetic art shop. Such fee must accompany the application for a permit to operate a 11 12 cosmetic art shop at the time such application is filed with the Board. 13 All cosmetic art shops in operation as of February 1, 1976, shall be required to make 14 application to the Board of Cosmetic Art, on forms supplied by the Board, for a permit 15 to operate. The fee required for such permit shall be three dollars (\$3.00) per active 16 booth in said shop. 17 Thereafter, all permits shall be renewed as of the first day of February of each and 18 every year, and the fee for annual renewal of cosmetic art shop permits shall be as set 19 forth in G.S. 88-21. No permit or certificate shall be transferable from one location to

20 another or from one owner to another at the same location. Each cosmetic art shop permit shall be conspicuously posted within such cosmetic art shop for which same is 21 issued."
