(b) The three assistant district attorney positions created for District 19B shall be
filled by three assistant district attorneys currently serving Moore County in District 20.
Sec. 4. Sections 1, 2, and 3 of this act become effective October 1, 1995, or
the date upon which those sections are approved under section 5 of the Voting Rights Act

5 of 1965, whichever is later. The remainder of this act is effective upon ratification.
