1	A BILL TO BE ENTITLED
2	AN ACT TO MAKE VARIOUS AMENDMENTS REGARDING GUARANTEED
3	ENERGY SAVINGS CONTRACTS IN ORDER TO ENHANCE THE VIABILITY
4	OF GUARANTEED ENERGY SAVINGS CONTRACTS BY LOCAL
5	GOVERNMENTAL UNITS AND TO REPEAL THE SUNSET FOR LOCAL
6	GOVERNMENTAL UNITS TO ENTER INTO THESE CONTRACTS.
7	The General Assembly of North Carolina enacts:
8	Section 1. G.S. 143-64.17(3) reads as rewritten:
9	"(3) 'Guaranteed energy savings contract' means a contract for the
10	evaluation, recommendation, or implementation of energy conservation
11	measures, including the design and installation of equipment or the
12	repair or replacement of existing equipment, in which all payments,
13	except obligations on termination of the contract before its expiration,
14	are to be made over time, and in which energy savings are guaranteed to
15	exceed costs. A guaranteed energy savings contract may not require the local
16	governmental unit to purchase a maintenance contract or other maintenance
17	agreement from the qualified provider who installs energy conservation
18	measures under the contract if the local governmental unit uses its own forces
19 20	for maintenance or if the local governmental unit can purchase maintenance
20	services at a lower cost from another provider or contractor."

1	Sec. 2. G.S. 143-64.17B reads as rewritten:
2	"§ 143-64.17B. Guaranteed energy savings contracts.
3	(a) A local governmental unit may enter into a guaranteed energy savings contract
4	with a qualified provider if all of the following apply:
5	(1) The term of the contract does not exceed eight years from the date of the
6 7	installation and acceptance by the local governmental unit of the energy conservation measures provided for under the contract.
8	(2) The local governmental unit finds that the energy savings resulting from
9	the performance of the contract will equal or exceed the total cost of the
10	contract.
11	(3) The energy conservation measures to be installed under the contract are
12	for an existing building.
12	(b) Before entering into a guaranteed energy savings contract, the local
14	governmental unit shall provide published notice of the meeting at which it proposes to
15	award the contract, the names of the parties to the proposed contract, and the contract's
16	purpose. The notice must be published at least 15 days before the date of the meeting.
17	(c) A qualified provider entering into a guaranteed energy savings contract under
18	this Part shall provide a bond to the local governmental unit in the amount equal to one
19	hundred percent (100%) of the total cost of the guaranteed energy savings contract to
20	assure the provider's faithful performance. Any bonds required by this subsection shall be
21	subject to the provisions of Article 3 of Chapter 44A of the General Statutes. If the
22	savings resulting from a guaranteed energy savings contract are not as great as projected
23	under the contract, contract and all required shortfall payments to the local governmental
24	unit have not been made, the local governmental unit may terminate the contract without
25	incurring any additional obligation to the qualified provider.
26	(d) As used in this section, 'total cost' shall include, but not be limited to, costs of
27	construction, costs of financing, and costs of maintenance and training during the term of
28	the contract. 'Total cost' also includes does not include any obligations on termination of
29	the contract before its expiration.
30	(e) <u>A guaranteed energy savings contract shall not require the local governmental</u>
31	unit to purchase a maintenance contract or other maintenance agreement that extends
32	beyond the term of the guaranteed energy savings contract."
33	Sec. 3. Section 10 of Chapter 775 of the 1993 Session Laws is repealed.
34	Sec. 4. This act is effective upon ratification.
