- 2 AN ACT TO CREATE THE NEW HANOVER INTERNATIONAL AIRPORT3 ECONOMIC DEVELOPMENT ZONE.
- 4 The General Assembly of North Carolina enacts:

5 Section 1. No municipality may annex any of the following described property 6 in New Hanover County, North Carolina, pursuant to Article 4A of Chapter 160A of the 7 General Statutes, or pursuant to any other provision of law:
