1 2 AN ACT TO APPROPRIATE FUNDS TO THE DEPARTMENT OF HUMAN 3 RESOURCES TO PROVIDE EARLY INTERVENTION SERVICES FOR 4 CHILDREN UNDER THREE WITH OR AT RISK FOR DISABILITIES. 5 The General Assembly of North Carolina enacts: Section 1. There is appropriated from the General Fund to the Department of 6 Human Resources the sum of five million four hundred forty-nine thousand eighty-nine 7 dollars (\$5,449,089) for the 1997-98 fiscal year and the sum of five million five hundred 8 thirty-one thousand four hundred seventy-four dollars (\$5,531,474) for the 1998-99 fiscal 9 year to provide early intervention services for children under three with or at risk for 10 disabilities. Of the funds appropriated in this act to the Department of Human Resources, 11 the sum of two million five hundred sixteen thousand eight hundred nine dollars 12 (\$2,516,809) for fiscal year 1997-98 and the sum of two million five hundred sixteen 13 thousand eight hundred nine dollars (\$2,516,809) for fiscal year 1998-99 shall be 14 allocated to the Division of Mental Health, Developmental Disabilities, and Substance 15 Abuse Services, the sum of one million four hundred twenty-five thousand eight hundred 16 fifty-eight dollars (\$1,425,858) for fiscal year 1997-98 and the sum of one million five 17 hundred seventy-one thousand eight hundred twenty-seven dollars (\$1,571,827) for fiscal 18 year 1998-99 shall be allocated to the Division of Services for the Blind, and the sum of 19
