May 27, 1998 A BILL TO BE ENTITLED AN ACT TO REGULATE THE OFF-PREMISE SALES OF MALT BEVERAGES IN KEGS AND MAKE BEER CONSUMPTION BY ANY PERSON UNDER TWENTY-ONE YEARS OF AGE A MISDEMEANOR. The General Assembly of North Carolina enacts: Section 1. G.S. 18B-1006 is amended by adding a new subsection to read: "(n) Keg Sales of Malt Beverages. – As used in this subsection, a 'keg' is a container capable of holding at least 7.75 gallons of malt beverage. The sale of malt beverages in kegs is subject to the following: Every keg of malt beverages supplied for sale by a malt beverage wholesaler to a permittee other than a hotel, a restaurant, or a private club shall be marked with a permanent identification number and shall also be tagged with a uniquely numbered and coded tag that meets all of the following requirements: That is issued by the Alcohol Law Enforcement Division to the a. malt beverage retailer upon the payment of a fee covering the cost of producing the tags. That is used for a single sale of the marked keg. <u>b.</u> That is removed from the keg upon the keg's return to the malt c. beverage wholesaler and maintained with the records of the sale.
