A BILL TO BE ENTITLED

1 AN ACT TO ENSURE THAT HEALTH BENEFIT PLANS IN NORTH CAROLINA
2 PROVIDE COVERAGE FOR ANESTHESIA AND HOSPITAL CHARGES IN
3 CERTAIN CASES INVOLVING YOUNG CHILDREN, PERSONS WITH
4 SERIOUS MENTAL OR PHYSICAL CONDITIONS, AND PERSONS WITH
5 SIGNIFICANT BEHAVIORAL PROBLEMS, WHERE THE AGE OR CONDITION
6 OR PROBLEM REQUIRES HOSPITALIZATION OR GENERAL ANESTHESIA
7 IN ORDER TO SAFELY AND EFFECTIVELY PERFORM DENTAL
8 PROCEDURES ON THE PATIENT INVOLVED.

10 The General Assembly of North Carolina enacts:

11 Section 1. Effective January 1, 2000, Article 3 of Chapter 58 of the General
12 Statutes is amended by adding the following new section to read:

13 **"§ 58-3-122. Anesthesia and hospital charges necessary for safe and effective**
14 **administration of dental procedures for young children, persons with**
15 **serious mental or physical conditions, and persons with significant**
16 **behavioral problems; coverage in health benefit plans.**

17 (a) All health benefit plans shall provide coverage for payment of anesthesia and
18 hospital or facility charges for services performed in a hospital or ambulatory surgical
19 facility in connection with dental procedures for children below the age of nine years,

1 persons with serious mental or physical conditions, and persons with significant
2 behavioral problems, where the provider treating the patient involved certifies that,
3 because of the patient's age or condition or problem, hospitalization or general anesthesia
4 is required in order to safely and effectively perform the procedures. The same
5 deductibles, coinsurance, network requirements, medical necessity provisions, and other
6 limitations as apply to physical illness benefits under the health benefit plan shall apply to
7 coverage for anesthesia and hospital or facility charges required to be covered under this
8 section.

9 (b) As used in this section, the term:

10 (1) 'Health benefit plan' means an accident and health insurance policy or
11 certificate; a nonprofit hospital or medical service corporation contract;
12 a health maintenance organization subscriber contract; a plan provided
13 by a multiple employer welfare arrangement; or a plan provided by
14 another benefit arrangement, to the extent permitted by the Employee
15 Retirement Income Security Act of 1974, as amended, or by any waiver
16 of or other exception to that Act provided under federal law or
17 regulation. 'Health benefit plan' does not mean any plan implemented
18 or administered by the North Carolina Department of Health and
19 Human Services or the United States Department of Health and Human
20 Services, or any successor agency, or its representatives. 'Health
21 benefit plan' also does not mean any of the following kinds of insurance:

22 a. Accident.

23 b. Credit.

24 c. Disability income.

25 d. Long-term care or nursing home care.

26 e. Medicare supplement.

27 f. Specified disease.

28 g. Dental or vision.

29 h. Coverage issued as a supplement to liability insurance.

30 i. Workers' compensation.

31 j. Medical payments under automobile or homeowners.

32 k. Hospital income or indemnity.

33 l. Insurance under which benefits are payable with or without
34 regard to fault and that is statutorily required to be contained in
35 any liability policy or equivalent self-insurance.

36 (2) 'Insurer' includes an insurance company subject to this Chapter, a
37 service corporation organized under Article 65 of this Chapter, a health
38 maintenance organization organized under Article 67 of this Chapter, or
39 a multiple employer welfare arrangement subject to Article 49 of this
40 Chapter."

41 Section 2. This act is effective when it becomes law and applies to health
42 benefit plans that are delivered, issued for delivery, or renewed on and after January 1,
43 2000. For purposes of this act, renewal of a health benefit policy, contract, or plan is

- 1 presumed to occur on each anniversary of the date on which coverage was first effective
- 2 on the person or persons covered by the health benefit plan.
