2	AN ACT TO PROVIDE THAT A PUBLIC CONDEMNOR USING "QUICK TAKE"IN		
3	AN EMINENT DOMAIN ACTION SHALL INCLUDE A NOTICE OF APPEAL		
4	RIGHTS IN THE COMPLAINTS COMMENCING THE ACTION.		
5	The General Assembly of North Carolina enacts:		
6	Section 1. G.S. 40A-41 reads as rewritten:		
7	"§ 40A-41. Institution of action and deposit.		
8	A public condemnor listed in G.S. 40A-3(b) or (c) shall institute a civil action to		
9	condemn property by filing in the superior court of any county in which the land is		
10	located a complaint containing a declaration of taking declaring that property therein is		
11	thereby taken for the use of the condemnor.		
12	The complaint shall contain or have attached thereto the following:		
13	(1) A statement of the authority under which and the public use for which		
14	the property is taken;		
15	(2) A description of the entire tract or tracts of land affected by the taking		
16	sufficient for the identification thereof;		
17	(3) A statement of the property taken and a description of the area taken		
18	sufficient for the identification thereof;

1	(4)	The names and addresses of those persons who the condemnor is	
2		informed and believes may be or, claim to be, owners of the property so	
3		far as the same can by reasonable diligence be ascertained, and if any	
4		such persons are infants, incompetents, inebriates or under any other	
5		disability, or their whereabouts or names unknown, it must be so stated;	
6	(5)	A statement of the sum of money estimated by the condemnor to be just	
7		compensation for the taking; and	
8	(6)	A statement as to whether the owner will be permitted to remove all or a	
9		specified portion of any timber, buildings, structures, permanent	
10		improvements, or fixtures situated on or affixed to the property.	
11	(7)	A statement as to such liens or other encumbrances as the condemnor is	
12		informed and believes are encumbrances upon the property and can by	
13		reasonable diligence be ascertained.	
14	(8)	A prayer that there be a determination of just compensation in	
15		accordance with the provisions of this Article.	
16	<u>(9)</u>	In the case of an action commenced to acquire property pursuant to G.S.	
17		40A-42(a), allowing immediate vesting of property rights in the	
18		condemnor upon the making of a deposit in accordance with this	
19		section, a notice of the owner's rights including the right to answer and	
20		to commence an action for injunctive relief.	
21	The filing of the complaint shall be accompanied by the deposit to the use of the owner of		
22	the sum of money estimated by the condemnor to be just compensation for the taking.		
23	Upon the filing of the complaint and the deposit of said sum, summons shall be issued to		
24	each owner of the property. The summons, together with a copy of the complaint and		
25	notice of the deposit shall be served upon the person named therein in the manner		
26	provided for the service of process under the provisions of G.S. 1A-1, Rule 4. The		
27	condemnor may amend the complaint and may increase the amount of its deposit with the		
28	court at any time while the proceeding is pending, and the owner shall have the same		
29	rights of withdrawal of this additional amount as set forth in G.S. 40A-44 of this		
30	Chapter."
