2	AN ACT TO AMEND THE REGIONAL TRANSPORTATION AUTHORITY ACT
3	CONCERNING JURISDICTION OF THE ENTIRE AREA OF THE COUNTY IN
4	CERTAIN CIRCUMSTANCES AND MEMBERSHIP OF THE AUTHORITY.
5	The General Assembly of North Carolina enacts:
6	Section 1. G.S. 160A-634(a) reads as rewritten:
7	"(a) The territorial jurisdiction and service area of the Authority shall be as
8	determined by the Board of Trustees consistent with its purpose, but shall initially consist
9	of those areas included within the Metropolitan Planning Organization boundaries. With
10	the consent by resolution of the affected board of county commissioners, the jurisdiction
11	and area may be expanded to include contiguous areas, but the total jurisdiction and
12	service area shall not exceed part or all of 12 counties. The jurisdiction and area include
13	the entire area of the county if the Board of Trustees has been expanded to include the
14	chairman or other member of the board of commissioners of that county pursuant to G.S.
15	<u>160A-635(4).</u> "
16	Section 2. G.S. 160A-635(a) reads as rewritten:
17	"(a) The governing body of an authority is the Board of Trustees. The Board of

6	(3)	The chair of each Metropolitan Planning Organization in the territorial
