March 30, 1999 A BILL TO BE ENTITLED AN ACT TO EXPAND THE LAW OF ASSAULT TO PROTECT SCHOOL PERSONNEL AND SCHOOL VOLUNTEERS. The General Assembly of North Carolina enacts: Section 1. G.S. 14-33 reads as rewritten: "§ 14-33. Misdemeanor assaults, batteries, and affrays, simple and aggravated; punishments. Any person who commits a simple assault or a simple assault and battery or participates in a simple affray is guilty of a Class 2 misdemeanor. Unless his conduct is covered under some other provision of law providing greater punishment, any person who commits any assault, assault and battery, or affray is guilty of a Class 1 misdemeanor if, in the course of the assault, assault and battery, or affray, he: (1) through (3) Repealed by Session Laws 1995, c. 507, s. 19.5(b); through (7) Repealed by Session Laws 1991, c. 525, s. 1; **(4)** Repealed by Session Laws 1995, c. 507, s. 19.5(b); (8) Commits an assault and battery against a sports official when the sports (9) official is discharging or attempting to discharge official duties at a

sports event who enforces the rules of the event, such as an umpire or referee, or a person who supervises the participants, such as a coach. A "sports event"includes any interscholastic or intramural athletic activity in a primary, middle, junior high, or high school, college, or university, any organized athletic activity sponsored by a community, business, or nonprofit organization, any athletic activity that is a professional or semiprofessional event, and any other organized athletic activity in the State.

- (c) Unless the conduct is covered under some other provision of law providing greater punishment, any person who commits any assault, assault and battery, or affray is guilty of a Class A1 misdemeanor if, in the course of the assault, assault and battery, or affray, he or she:
 - (1) Inflicts serious injury upon another person or uses a deadly weapon;
 - (2) Assaults a female, he being a male person at least 18 years of age;
 - (3) Assaults a child under the age of 12 years;
 - (4) Assaults an officer or employee of the State or any political subdivision of the State, when the officer or employee is discharging or attempting to discharge his official duties; or
 - (5) Assaults a school bus driver, school bus monitor, or school employee who is boarding the school bus or who is on the school bus.
 - (6) Assaults a school employee or school volunteer when the employee or volunteer is discharging or attempting to discharge his or her duties as an employee or volunteer, or assaults a school employee or school volunteer as a result of the discharge or attempt to discharge that individual's duties as a school employee or school volunteer. For purposes of this subdivision, the following definitions shall apply:
 - <u>a.</u> "Duties"means:
 - 1. All activities on school property;
 - 2. All activities, wherever occurring, during a school authorized event or the accompanying of students to or from that event; and
 - 3. All activities relating to the operation of school transportation.
 - <u>b.</u> "Employee" or "volunteer" means:
 - 1. An employee of a local board of education; or a charter school authorized under G.S. 115C-238.29D, or a nonpublic school which has filed intent to operate under Part 1 or Part 2 of Article 39 of Chapter 115C of the General Statutes;
 - 2. An independent contractor or an employee of an independent contractor of a local board of education, charter school authorized under G.S. 115C-238.29D, or a nonpublic school which has filed intent to operate under
