A BILL TO BE ENTITLED AN ACT TO REQUEST THE NORTH CAROLINA SUPREME COURT TO ADOPT 3 RULES **ESTABLISHING** MINIMUM **STANDARDS** FOR **DEFENSE** 4 ATTORNEYS, PROSECUTORS, AND JUDGES HANDLING CAPITAL CASES.

SECTION 1. The Supreme Court is respectfully requested to adopt rules to improve North Carolina's system of capital punishment by establishing minimum standards of training and experience for defense attorneys, prosecutors, and judges handling capital cases. These rules should specify the minimum number of years of legal experience and the minimum amount of felony case experience required of any defense attorney, prosecutor, or judge participating in the trial of a capital case, and may also require specialized training in capital case litigation for any or all of those participants in capital trials.

SECTION 2. G.S. 7A-498.5(c) reads as rewritten:

- The Commission shall develop standards governing the provision of services under this Article. The standards shall include:
 - Standards for maintaining and operating regional and district public (1) defender offices and appellate defender offices, including requirements regarding qualifications, training, and size of the legal and supporting staff:
 - Standards prescribing minimum experience, training, and other (2) qualifications for appointed counsel;
 - Standards for public defender and appointed counsel caseloads: (3)
 - Standards for the performance of public defenders and appointed **(4)** counsel;
