"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

Distribution of Fees. - The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:

SECTION 4. G.S. 20-81.12 is amended by adding a new subsection to read: "(b17) "Choose Life". – The Division shall receive 300 or more applications for a "Choose Life" plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Choose Life" plates to the Tri-County Crisis Prevention Center, Inc., of Burnsville, North Carolina, for further distribution in accordance with this subsection. Funds received by the Tri-County Crisis Prevention Center, Inc., pursuant to this section shall be distributed annually to each county in the ratio that the number of "Choose Life" plates sold to residents of that county bears to the total number of "Choose Life" plates issued by the Division. Each county receiving funds pursuant to this subsection shall distribute the funds to nongovernmental, not-for-profit agencies within the county that provide pregnancy crisis services that are limited to counseling and meeting the physical needs of pregnant women who are committed to either raising their own children or placing their children for adoption. Funds received pursuant to this subsection may not be distributed to any agency that is involved or associated with abortion activities, including counseling for or referrals to abortion clinics, providing medical abortion related procedures, or proabortion advertising, and these funds may not be distributed to any agency that charges women for services received. The Tri-County Crisis Prevention Center, Inc., shall provide the State Auditor with an annual accounting, prepared by a certified public accountant, of the receipt and disbursement of funds received pursuant to this subsection."

SECTION 5. This act is effective when it becomes law.
