5	The General Assembly of North Carolina enacts:			
6	SECTION 1. Article 100 of Chapter 15A of the General Statutes is amended			
7	by adding a new section to read:			
8	"§ 15A-2004. Mentally retarded defendants; death sentence prohibited.			
9	(a) The following definitions apply in this section:			
10	<u>(1)</u>	Mentally retarded Significantly subaverage intellectuation		
11		existing concurrently with impairment in adaptive fur	nctioning, and	
12		manifested before the age of 18.		
13	<u>(2)</u>	Significantly subaverage intellectual functioning A		
14		quotient of 70 or below on an individually administered	d standardized

16	(b) Notwithstanding any provision of law to the contrary, no defendant who is			
17	mentally retarded shall be sentenced to death.			
18	(c) Upon motion of the defendant prior to trial, the court shall conduct a hearing			
19	to determine whether the defendant is mentally retarded. The intelligence quotient test			
20	referred to in subdivision (a)(2) of this section must have been administered prior to the			
21	commission of the alleged crime. The defendant has the burden of production and			
22	persuasion to demonstrate mental retardation by a preponderance of the evidence. If the			
23	court determines the defendant is mentally retarded, the court shall declare the case			
24	noncapital, and the State may not seek the death penalty against the defendant.			
25	(d) <u>The pretrial determination of the court shall not preclude the defendant from</u>			

26 raising any legal defense during the trial.

- 1 (e) The provisions of this section do not preclude the sentencing of a mentally
- 2 retarded offender to any other sentence authorized by G.S. 14-17 for the crime of 3 murder in the first degree."
- 4 **SECTION 2.** This act becomes effective December 1, 2001, and applies to trials begun on or after that date.
