## SESSION LAW 2001-49 <br> SENATE BILL 677

## AN ACT ADDING CERTAIN DESCRIBED PROPERTY TO THE CORPORATE LIMITS OF THE TOWN OF WELDON.

The General Assembly of North Carolina enacts:
SECTION 1. The following described property is added to the corporate limits of the Town of Weldon:

A plat of said property is recorded at Plat Cabinet 4, Slide 125, Halifax Public Registry.

SECTION 2. This act is effective when it becomes law. In the General Assembly read three times and ratified this the $7^{\text {th }}$ day of May, 2001.
