PROGRAM(S) AFFECTED: Department of Insurance

EFFECTIVE DATE: This act is effective when it becomes law.

BILL SUMMARY: This act simplifies the Department of Insurance fee schedule in a revenue neutral manner by eliminating a number of fees and increasing the license application and renewal fees.

ASSUMPTIONS AND METHODOLOGY:

The chart on the next page list the fees charged by the Department of Insurance, the estimated number of transactions in FY 2000-01, and the revenue estimated to be collected and deposited into the General Fund in FY 2000-01.

The Department requests to simplify its fee structure by abolishing many of its smaller fees and replacing the lost revenue by increasing it annual license fee and filing/examination fee. The chart below shows the revised fee structure and the estimated revenue from the fee change. While the bill is proposed to be revenue neutral, there is a small revenue gain from the revised fee schedule.
