5	"§ 6-19. When costs allowed as of course to defendant.		
6	Costs shall be allowed as of course to the defendant, in the actions mentioned in the		
7	preceding section <u>G.S. 6-18</u> unless the plaintiff be entitled to costs therein. In all actions		
8	where there are several defendants not united in interest, and making separate defenses		
9	by separate answers, and the plaintiff fails to recover judgment against all, the court		
10	may award costs to such of the defendants as have judgment in their favor or any of		
11	them."		
12		TION 2. G.S. 6-20 reads as rewritten:

3	(7)	Fees of guardians ad litem, referees, receivers, commissioners,
4		surveyors, arbitrators, appraisers, and other similar court appointees, as
5		provided by law. The fee of such appointees shall include reasonable
6		reimbursement for stenographic assistance, when necessary.
7	(8)	Fees of interpreters, when authorized and approved by the court.
8	(9)	Premiums for surety bonds for prosecution, as authorized by G.S.
9		1-109.
10	<u>(10)</u>	In the discretion of the court, reasonable expenses directly related to
11		the taking of depositions, excluding attorney's fees."
