A BILL TO BE ENTITLED 1 2 AN ACT TO INCREASE THE CRIMINAL PENALTY FOR CERTAIN REPEAT 3 OFFENSES OF MISDEMEANOR LARCENY OR SHOPLIFTING. 4 The General Assembly of North Carolina enacts: 5 **SECTION 1**. G.S. 14-72 reads as rewritten: "§ 14-72. Larceny of property; receiving stolen goods or possessing stolen goods. 6 Larceny of goods of the value of more than one thousand dollars (\$1,000) is a 7 (a) 8 Class H felony. The receiving or possessing of stolen goods of the value of more than one thousand dollars (\$1,000) while knowing or having reasonable grounds to believe 9 that the goods are stolen is a Class H felony. Larceny as provided in subsection (b) of 10 this section is a Class H felony. Receiving or possession of stolen goods as provided in 11 subsection (c) of this section is a Class H felony. Except as provided in subsections 12 (b)(a1), (b), and (c) of this section, larceny of property, or the receiving or possession of 13 14 stolen goods knowing or having reasonable grounds to believe them to be stolen, property where the value of the property or goods is not more than one thousand dollars 15 (\$1,000), is a Class 1 misdemeanor. Except as provided in subsections (b) and (c) of this 16 section, a person receiving or possessing stolen goods knowing or having reasonable 17 grounds to believe them to be stolen where the value of the goods is not more than one 18 thousand dollars (\$1,000) is guilty of a Class 1 misdemeanor. In all cases of doubt, the 19 jury shall, in the verdict, fix the value of the property stolen. 20 A person convicted within three years of a fifth or subsequent offense of 21 (a1) 22 larceny of property where the value of the property is not more than one thousand dollars (\$1,000) is guilty of a Class H felony. 23 The crime of larceny is a felony, without regard to the value of the property in 24 (b) 25 question, if the larceny is: From the person; or 26 (1)

1 2	(2)	Committed pursuant to a violation of G.S. 14-51, 14-53, 14-54 or 14-57; or
3	(3)	Of any explosive or incendiary device or substance. As used in this
4	(5)	section, the phrase "explosive or incendiary device or substance" shall
5		include any explosive or incendiary grenade or bomb; any dynamite,
6		blasting powder, nitroglycerin, TNT, or other high explosive; or any
7		device, ingredient for such device, or type or quantity of substance

17		A "firearm," which at the time of theft is not capable of being fired,
18		shall be included within this definition if it can be made to work. This
19		definition shall not include air rifles or air pistols.
20	(5)	Of any record or paper in the custody of the North Carolina State
21		Archives as defined by G.S. 121-2(7) and 121-2(8).
22	(c) The c	rime of possessing stolen goods knowing or having reasonable grounds
23	to believe them to be stolen in the circumstances described in subsection (b) is a felony	
24	or the crime of receiving stolen goods knowing or having reasonable grounds to believe	
25	them to be stolen in the circumstances described in subsection (b) is a felony, without	
26	regard to the value of the property in question.	
27	(d) Where the larceny or receiving or possession of stolen goods as described in	
28	subsection (a) of this section involves the merchandise of any store, a merchant, a	
29	merchant's agent, a merchant's employee, or a peace officer who detains or causes the	
30	arrest of any person shall not be held civilly liable for detention, malicious prosecution,	
31	false imprisonment, or false arrest of the person detained or arrested, when such	
32	detention is upon the premises of the store or in a reasonable proximity thereto, is in a	
33	reasonable manner for a reasonable length of time, and, if in detaining or in causing the	
34	arrest of such person, the merchant, the merchant's agent, the merchant's employee, or	
35	the peace officer had, at the time of the detention or arrest, probable cause to believe	
36	that the person committed an offense under subsection (a) of this section. If the person	
37	being detained by the merchant, the merchant's agent, or the merchant's employee, is a	
38	minor under the age of 18 years, the merchant, the merchant's agent, or the merchant's	

guardian of the minor, during the period of detention. A merchant, a merchant's agent,
or a merchant's employee, who makes a reasonable effort to call or notify the parent or
guardian of the minor shall not be held civilly liable for failing to notify the parent or
guardian of the minor."

- 1 "(d2) Notwithstanding subsection (e) of this section, any person convicted of a fifth
- 2 <u>or subsequent violation of subsection (a) or (d) of this section within three years is</u> 3 <u>wilty of a Class H felony "</u>
- 3 guilty of a Class H felony."
- 4 **SECTION 3.** This act becomes effective December 1, 2003, and applies to offenses committed on or after that date.
