EFFECTIVE DATE: This act is effective when it becomes law.

BILL SUMMARY: The bill authorizes the State Board of Barber Examiners to assess civil penalties, changes the number of instructors per enrolled students in barber colleges and schools, and increases the maximum fee amounts.

ASSUMPTIONS AND METHODOLOGY:

Fees

Section 8 of the bill increases the maximum fees that the State Board of Barber Examiners can charge. The maximum fees have not been changed since the 1989 Session (Chapter 1029), however several late fees were added in the 1995 Session (Chapter 605). It is the practice of most

occupational licensing boards to set their maximum fees at a rate high enough that they will not have to return to the General Assembly for several sessions. The chart below shows the proposed fee recommended by the Executive Director of the Board of Barber Examiners if the bill is passed. Based on the current number of licensees, the Board would gain \$213,630 each year in additional income under the staff proposed rates. If the maximum rates were approved, the Board would gain \$444,450 annually.

Since the Board has no projection of future year growth, it is assumed that the number of barbers will grow at the same rate as the state population. The State Demographics section of the Office of State Budget and Management projects a 1.7% annual growth in population between 2003 and

2009. This growth rate was applied to the number of barbers, barber apprentices, exams, and student permits. The number of barbershops was increased by 150 each year based on the Board's experience of 200 shops opening and 50 shops closing annually.

As for the Board's operating expenses, their FY 2002-03 financial report showed the Board spent \$13,617 more than they collected in fees and investments (Expenses = \$439,677; Revenue = \$426,060). The Board's cash reserve at the end of June 30, 2003 was \$271,101.

Penalties

Section 10 of the bill allows the Board to assess a \$1,500 civil penalty. The proceeds of this penalty go to the Civil Penalty and Forfeiture Fund, not to the Board. Since this power is discretionary, no estimate can be made at this time.
