5	The General Assembly of North Carolina enacts:
6	SECTION 1. G.S. 116D-26(b) reads as rewritten:
7	"(b) Approval Required The Board of Governors shall not issue any special
8	obligation bonds for a project at an institution unless the board of trustees of that
9	institution has approved the issuance of bonds for that project. The Except for special
10	obligation bonds, (i) the proceeds of which are to be used solely for acquisition of
11	equipment, and (ii) the amount of which does not exceed five percent (5%) of the
12	operating and nonoperating revenues of the constituent institution for whose benefit the
13	special obligation bonds are to be issued, as shown in the constituent institution's most
14	recent audited financial statements, the Board of Governors shall not issue special
15	obligation bonds under this Article until (i) the effective date of legislation enacted by
16	the General Assembly authorizing the undertaking of the special obligation bond project
17	to be financed and fixing the maximum aggregate principal amount of special obligation
18	bonds that shall be issued for that purpose.purpose, and (ii) the board of trustees of the
19	constituent institution for whose benefit the special obligation bonds are to be issued has
20	approved the issuance of bonds for that project. In submitting proposed special
21	obligation bond projects to the General Assembly for approval, the Board of Governors
22	shall submit information on the need for each project, project costs, estimates of
23	increased operating costs upon completion, estimated debt service requirements, and the
24	sources and amounts of obligated resources to be pledged for the repayment of the
25	bonds. If the obligated resources to repay the bonds or to operate the proposed project
26	potentially involve increased costs to students or to the General Fund, these costs shall
27	be identified in the Board of Governors' submission.

General Assembly of North Carolina

Except as provided in this Article, special obligation bond projects may be 1 undertaken, special obligation bonds may be issued, and other powers vested in the 2 3 Board of Governors under this Article may be exercised by the Board without obtaining the consent of any department, division, commission, board, bureau, or agency of the 4 State and without any other proceedings or the happening of any other conditions or 5 things other than those proceedings, conditions, or things which are specifically 6 required by this Article." 7 **SECTION 2.** This act is effective when it becomes law. 8
