A BILL TO BE ENTITLED

1 AN ACT TO ADD GASTON, SURRY, AND WILKES COUNTIES, AND THE
2 TOWNS OF OCEAN ISLE BEACH AND SURF CITY, TO THE AREAS IN
3 WHICH LAW ENFORCEMENT OFFICERS AND EMPLOYEES MAY
4 OPERATE UNREGISTERED ALL-TERRAIN VEHICLES ON HIGHWAYS
5 WITH SPEED LIMITS OF THIRTY-FIVE MILES PER HOUR OR LESS AND
6 TO ALLOW THE CITY OF WHITEVILLE TO DECLARE RESIDENTIAL
7 BUILDINGS IN COMMUNITY DEVELOPMENT TARGET AREAS UNSAFE
8 AND TO DEMOLISH THOSE BUILDINGS USING THE SAME PROCESS
9 AUTHORIZED FOR THE DEMOLITION OF UNSAFE NONRESIDENTIAL
10 BUILDINGS.

12 The General Assembly of North Carolina enacts:

13 **SECTION 1.** If Senate Bill 1199, 2005 Regular Session, does not become
14 law, then Section 3 of S.L. 2004-108, as rewritten by S.L. 2005-305 and S.L. 2006-25,
15 reads as rewritten:

16 "**SECTION 3.** Section 1 of this act applies to the City of Albemarle, and the Towns
17 of Beaufort, Highlands, Southern Shores, and Mint Hill only. Section 2 of this act
18 applies to the Towns of Cramerton, Dallas, Duck, Kill Devil Hills, Kitty Hawk, Nags
19 Head, Ocean Isle Beach, Surf City, and the City of Kings Mountain and the ~~County~~
20 Counties of Currituck-Currituck, Gaston, Surry, and Wilkes only. The term 'municipal
21 employee' shall include employees of a county."

22 **SECTION 2.** If Senate Bill 1199, 2005 Regular Session, becomes law, then
23 Section 3 of S.L. 2004-108, as rewritten by S.L. 2005-305, S.L. 2006-25, and Senate
24 Bill 1199, 2005 Regular Session, reads as rewritten:

25 "**SECTION 3.** Section 1 of this act applies to the City of Albemarle and the Towns
26 of Beaufort, Highlands, Southern Shores, and Mint Hill only. Section 2 of this act
27 applies to the Towns of Cramerton, Dallas, Duck, Kill Devil Hills, Kitty Hawk, ~~Nags~~
28 ~~Head~~ Nags Head, Ocean Isle Beach, Surf City, and Stanley, the Cities of Belmont,

1 Cherryville, Gastonia, Kings Mountain and Mount Holly, and the Counties of ~~Cleveland~~
2 ~~and Currituck~~ Cleveland, Currituck, Gaston, Surry, and Wilkes only. The term
3 'municipal employee' shall include employees of a county."

4 **SECTION 3.** Section 4 of S.L. 2002-118, as amended by S.L. 2003-23, S.L.
5 2003-42, and S.L. 2004-6, reads as rewritten:

6 **"SECTION 4.** Sections 1 and 2 of this act apply to the Cities of Clinton, Durham,
7 Fayetteville, Goldsboro, High Point, ~~and Lumberton,~~ Lumberton, and Whiteville, and
8 the Towns of Garner, Franklin, Hope Mills and Spring Lake only."

9 **SECTION 4.** This act is effective when it becomes law.
