8	The General Assembly of North Carolina enacts:
9	SECTION 1. G.S. 160A-299(a) reads as rewritten:
10	"§ 160A-299. Procedure for permanently closing streets and alleys.
11	(a) When a city proposes to permanently close any street or public alley, the
12	council shall first adopt a resolution declaring its intent to close the street or alley and
13	calling a public hearing on the question. The resolution shall be published once a week
14	for four successive weeks prior to the hearing, A notice of the closing and date set for
15	the public hearing shall be published once in a newspaper of general circulation in the
16	area of the street or alley closing. The notice shall be published not less than 10 days nor
17	more than 25 days from the date set for the hearing. a copy thereof A copy of the
18	resolution shall be sent by registered or certified mail to all owners of property
19	adjoining the street or alley as shown on the county tax records, records prior to
20	publishing any notice required by this section, and a notice of the closing and public
21	hearing shall be prominently posted in at least two places along the street or alley. If the
22	street or alley is under the authority and control of the Department of Transportation, a
23	copy of the resolution shall be mailed to the Department of Transportation. At the
24	hearing, any person may be heard on the question of whether or not the closing would
25	be detrimental to the public interest, or the property rights of any individual. If it
26	appears to the satisfaction of the council after the hearing that closing the street or alley
27	is not contrary to the public interest, and that no individual owning property in the

- 1 vicinity of the street or alley or in the subdivision in which it is located would thereby
- 2 be deprived of reasonable means of ingress and egress to his property, the council may
- 3 adopt an order closing the street or alley. A certified copy of the order (or judgment of
- 4 the court) shall be filed in the office of the register of deeds of the county in which the
- 5 street, or any portion thereof, is located."
