A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS FOR TWO ADDITIONAL ASSISTANT

DISTRICT ATTORNEYS AND TWO ADDITIONAL VICTIM WITNESS LEGAL

ASSISTANTS FOR THE 19A PROSECUTORIAL DISTRICT.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of two hundred ninety-nine thousand four hundred sixty-two dollars (\$299,462) for the 2007-2008 fiscal year and the sum of two hundred eighty-seven thousand nine hundred ten dollars (\$287,910) for the 2008-2009 fiscal year to fund the two additional assistant district attorneys authorized for Prosecutorial District 19A by this act and two victim witness legal assistants for District 19A.

1 **SECTION 3.** This act becomes effective July 1, 2007.
