Subject to all of 22 Grantor's right, title, and interest, if any, in the following: (1) "Non-exclusive access easement 23 for ingress and egress" as recorded in Book 4137 Page 0536 at the New Hanover County 24 Registry. (2) "20' x 50' Bellsouth Easement" as recorded in Book 4639 Page 0721 at the New 25 Hanover County Registry. (3) "Deed of Easement" for Progress Energy Carolinas, Inc., as 26 recorded in Book 4169 Page 239 at the New Hanover County Registry. 29 **SECTION 4.** The corporate limits of the City of Wilmington are extended to 30 include the following described area:

31 Magnolia Trace Tract: A tract of land bound on the Southwest by Carolina Beach 32 Road (U.S. Hwy. 421), a 160' public right-of-way; on the Northwest by the lands, now or 33 formerly, of Silver Lake Baptist Church, recorded among the land records of the New Hanover 34 County Registry in Deed Book 1052, at Page 110; on the Northeast by the lands, now or 35 formerly, of South College Road Associates, recorded in Deed Book 1417, at Page 1317; on the 36 Southeast by Treetops HOA, Inc., recorded in Deed Book 3966, at Page 163; and being more 37 particularly described as follows: BEGINNING at a point in the northeastern boundary of 38 Carolina Beach Road, said point being located North 35°29'0" West, 168.00' along the right-of-39 way from its intersection with the centerline of Winding Branches Drive, a 50' private right-of-40 way; and running thence from the point of beginning with the right-of-way of Carolina Beach 41 Road, North 35°28'46" West, 307.01 feet to a point; thence North 36°30'11" West, 101.04 feet 42 to a point; thence North 35°49'34" West, 99.49 feet to a point; thence with the Silver Lake 43 Church line, North 54°19'50" East, 879.21 feet to a point; thence with the South College Road Associates line, South 12°10'42" West, 150.06 feet to a point; thence South 11°55'45" West, 44 45 148.07 feet to a point; thence with the Treetops HOA line, South 11°54'20" West, 227.12 feet to 46 a point; thence South 36°55'00" West, 513.79 feet to the point and place of beginning, 47 containing 6.42 acres, more or less.
