1 A BILL TO BE ENTITLED 2 AN ACT ADDING CERTAIN DESCRIBED PROPERTY TO THE CORPORATE LIMITS 3 OF THE TOWN OF PLEASANT GARDEN AT THE REQUEST OF THE PROPERTY 4 OWNER AND THE TOWN; AND REMOVING CERTAIN DESCRIBED PROPERTY 5 FROM THE CORPORATE LIMITS OF THE TOWN OF WATHA. 6 The General Assembly of North Carolina enacts: 7 **SECTION 1.(a)** The following described property is added to the corporate limits 8 of the Town of Pleasant Garden: 9 That certain tract or parcel of land lying and being situate in Guilford County, North 10 Carolina, more particularly described in Deed Book 2849, Page 887, Guilford County Register 11 of Deeds as follows: 12 BEGINNING at an iron stake in the eastern right-of-way line of N.C. Highway 22, 13 said point being the southwest corner of that tract conveyed to Frank M. Plunkett et ux by deed 14 recorded in Book 2456, page 444, in the Office of the Register of Deeds of Guilford County, 15 North Carolina, and running thence from said beginning point, and with the south line of Jesse R. Hawkins, South 85° 04' East 250.0 feet to an iron stake, Hawkins' southeast corner; thence 16 17 again with Hawkins' line North 06° 28' East 100.0 feet to an iron stake in George Jackson's 18 south line; thence with George Jackson's line South 85° 04' East approximately 1,416.5 feet to 19 an oak tree, a corner with Lora L. Harris; thence with the Harris line South 01° 00' West 700.0 20 feet to an iron stake; thence a new line with the Grantors North 85° 04' West approximately 21 1,666.5 feet to an iron stake in the eastern right-of-way line of N.C. Highway 22; thence 22 northwardly with the eastern right-of-way line of said road 600.00 feet to the point of 23 BEGINNING, containing 26.2 acres more or less, and being the northern portion of the First 24 Tract described in that deed from Cameron L. Tucker to W. Charles Kirkman, recorded in Book 124, page 40, Guilford County Registry, and devised to Robert L. Kirkman by the Will of 25 26 W. Charles Kirkman. Said property being known as 4591 Alliance Church Road, Pleasant Garden, North Carolina; Guilford County Tax Parcel ID Number 0130818. 27 28 **SECTION 1.(b)** The property described in Section 1(a) of this act is being added to 29 the corporate limits of the Town of Pleasant Garden at the request of the property owner and 30 the Town and therefore is a voluntary annexation of the property. **SECTION 1.(c)** This section becomes effective July 1, 2014. 31 32 **SECTION 2.(a)** The following described property is removed from the corporate 33 limits of the Town of Watha: 34 Located in Union Township, Pender County, North Carolina adjacent to and West of the paved centerline of U.S. Highway No. 117, adjacent to and East of the Eastern 35

right-of-way line of Interstate Highway No. 40 and being more fully described as follows, to 1 2 wit: 3 BEGINNING at a point in the paved centerline of U.S. Highway No. 117, said point 4 being located along said line at a point that is North 32 degrees 40 minutes 32 seconds West 5 710.405 feet (said point having N.C. Grid Coordinates: N=334,595.63' & E=2,319,710.56' 6 NAD 83/NSRS 2007) from N.C. Grid Monument "CHERRY" which as N.C. Grid Coordinates 7 of N=333,997.65' & E=2,320,094.10 and CF=0.99992975.3 (NAD 83/NSRS 2007); and 8 running thence from the Beginning so located, along an old marked line South 44 degrees 56 9 minutes 03 seconds West 2,260.33 feet (passing over an existing iron stake in line at 75.92 feet) 10 to an existing iron pipe in the Eastern right-of-way line of Interstate Highway No. 40; thence 11 with said right-of-way line North 09 degrees 01 minutes 04 seconds West 43.49 feet to an 12 existing concrete right-of-way monument in line; thence continuing with said road right-of-way 13 line North 09 degrees 26 minutes 49 seconds West 402.66 feet to an existing iron stake in said 14 line; thence continuing with said road right-of-way line North 09 degrees 26 minutes 25 15 seconds West 557.706 feet to an existing iron pipe that marks the Southwestern corner of the 16 Town of Watha land shown on a map recorded in Map Book 48, at Page 83 of the Pender 17 County Registry; thence along the Southeastern line of said lands North 43 degrees 28 minutes 18 17 seconds East 512.95 feet to an existing iron pipe that marks the Southeastern corner of said 19 Town of Watha lands; thence with the Betty Crumpler line North 44 degrees 15 minutes 04 seconds East 986.79 feet to an existing 1 inch square iron stake; thence continuing with the 20 21 Betty Crumpler line North 42 degrees 17 minutes 02 seconds East 632.61 feet to an existing 22 nail and cap in the paved centerline of U.S. Highway No. 117; thence with said paved 23 centerline of U.S. Highway No. 117 South 12 degrees 49 minutes 19 seconds East 389.98 feet 24 to the point of beginning of a curve to the left in said roadway; thence continuing with the 25 curved paved centerline of said road as it curves to the left the following chord courses and 26 distances: South 13 degrees 40 minutes 40 seconds East 122.78 feet, South 16 degrees 15 27 minutes 03 seconds East 101.20 feet, South 19 degrees 19 minutes 52 seconds East 100.65 feet 28 and South 23 degrees 36 minutes 10 seconds East 129.57 feet to an existing "PK" Nail in said 29 road centerline that is directly above the center of a large box concrete culvert that 30 accommodates the waters of Powell's Pond Branch beneath the roadway; thence continuing 31 with said road centerline South 26 degrees 55 minutes 51 seconds East 142.35 feet to the 32 Beginning, containing 39.669 acres, more or less after the exclusion of the portion of U.S. 33 Highway No. 117 (150 foot wide right-of-way) contained within the above-described 34 boundaries and is as surveyed by Daniel H. Thompson, NCPLS No. L-2174 of Burgaw, North 35 Carolina during April 2013. As a reference to the described tracts, see Deed Book 1379, at 36 Page 68, Deed Book 632, at Page 64 – Tracts 1 and 2, Deed Book 2161, at Page 310 and Deed 37 Book 3209, at Page 003 of the Pender County Registry. Also, see Map Book 40, at Page 34, 38 Map Book 52, at Page 43 and Map Book 48, at Page 83 each recorded in the Office of the 39 Pender County Register of Deeds. That the above-described tract of real property is shown on 40 survey map entitled "Annexation Map To The Town of Watha, North Carolina" as prepared by 41 Daniel H. Thompson, NCPLS on April 25, 2013 and recorded in Map Book 55, at Page 68 in 42 the Office of the Pender County Register of Deeds, State of North Carolina.

43 **SECTION 2.(b)** This section has no effect upon the validity of any liens of the 44 Town of Watha for ad valorem taxes or special assessments outstanding before the effective 45 date of this section. Such liens may be collected or foreclosed upon after the effective date of 46 this section as though the property were still within the corporate limits of the Town of Watha.

SECTION 2.(c) This section becomes effective June 30, 2014.

48 **SECTION 3.** Except as otherwise provided, this act is effective when it becomes 49 law.
