A BILL TO BE ENTITLED

2 THE OVERSIGHT OF METROPOLITAN AN ACT TO STUDY PLANNING 3 **ORGANIZATIONS** TRANSPORTATION AND RURAL PLANNING 4 ORGANIZATIONS AND THEIR ROLE IN TRANSPORTATION PLANNING. 5

The General Assembly of North Carolina enacts:

SECTION 1. The Study Committee on Metropolitan Planning Organizations and 6 7 Rural Transportation Planning Organizations is created. The Committee shall consist of five 8 members of the House of Representatives, appointed by the Speaker of the House of 9 Representatives, and five members of the Senate, appointed by the President Pro Tempore of 10 the Senate. The Speaker of the House of Representatives and the President Pro Tempore of the Senate shall each designate one member as a cochair. Vacancies to the Committee shall be 11 12 filled by the same appointing authority making the initial appointment. The Committee will 13 meet upon the call of the cochairs. A quorum shall be a majority of the Committee members.

14 SECTION 2. The Committee shall study the organization, structure, and oversight of Metropolitan Planning Organizations and Rural Transportation Planning Organizations, the 15 role they play in transportation planning, and the way the organization, structure, and oversight 16 17 might be revised to better match their role in transportation planning while maintaining 18 compliance with federal transportation requirements.

19 **SECTION 3.** The Committee, while in the discharge of its official duties, may 20 exercise all powers provided for under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4. 21 The Committee may meet in the Legislative Building or the Legislative Office Building. 22 Members of the Committee shall receive subsistence and travel expenses at the rates set forth in 23 G.S. 120-3.1.

24 The Legislative Services Commission, through the Legislative Services Officer, shall assign professional staff to assist the Committee in its work. The House of 25 26 Representatives shall assign clerical staff to the Committee, and the expenses relating to the 27 clerical employees shall be borne by the Committee. The Committee may contract for 28 professional, clerical, or consultant services, as provided by G.S. 120-32.02.

29 **SECTION 4.** The Committee may make an interim report, including any proposed 30 legislation, to the 2016 Session of the 2015 General Assembly. The Committee shall terminate 31 upon filing its final report or upon the convening of the 2016 Session of the 2015 General 32 Assembly, whichever is earlier.
