1	A BILL TO BE ENTITLED
2	AN ACT TO PROVIDE RECIPROCAL CONCEALED HANDGUN RIGHTS TO
3	CONCEALED HANDGUN PERMIT HOLDERS OF OTHER STATES.
4	The General Assembly of North Carolina enacts:
5	SECTION 1. Article 54B of Chapter 14 of the General Statutes is amended
6	by adding a new section to read:
7	" <u>§ 14-415.24. Reciprocity; out-of-state handgun permits.</u>
8	(a) A valid concealed handgun permit or license issued by another state is valid
9	in North Carolina if that state both:
10	(1) Grants permits pursuant to requirements substantially equal to the
11	requirements set forth in G.S. 14-415.12.
12	(2) Grants the same right to residents of North Carolina who have valid
13	concealed handgun permits issued pursuant to this Article in their
14	possession while carrying concealed weapons in that state.
15	(b) The Attorney General shall determine which states meet the requirements of
16	this section, maintain a registry of such states on the North Carolina Criminal
17	Information Network, and make the registry available to law enforcement officers for
18	investigative purposes.
19	(c) The provisions of G.S. 14-415.11(a) and (c) apply to a nonresident whose
20	concealed handgun permit or license from another state is honored by North Carolina in
21	accordance with the reciprocity provisions of this section.

The Department of Justice shall, not later than 30 days after July 15, 2003, (d) 1 2 and not less than once every six months thereafter, make written inquiry of the 3 concealed handgun permitting authorities in each other state as to: (i) whether a North 4 Carolina resident may carry a concealed handgun in their state based upon having a 5 valid North Carolina concealed handgun permit, and (ii) whether a North Carolina 6 resident may apply for a concealed handgun permit in that state based upon having a valid North Carolina concealed handgun permit. The Department of Justice shall 7 8 attempt to secure from each state permission for North Carolina residents who hold a 9 valid North Carolina concealed handgun permit to carry a concealed handgun in that 10 state, either on the basis of the North Carolina permit or on the basis that the North Carolina permit is sufficient to permit the issuance of a similar license or permit by the 11 12 other state." 13 **SECTION 2.** G.S. 14-415.24(b), as enacted by this act, is effective when 14 this act becomes law. The Attorney General shall implement G.S. 14-415.24(b), as 15 enacted by Section 1 of this act, within 60 days after this act becomes law. The

16 remainder of this act becomes effective 60 days after this act becomes law.
