1	A BILL TO BE ENTITLED
2	AN ACT TO CONVEY CERTAIN DESCRIBED PROPERTY TO THE COUNTY OF
3	CURRITUCK.
4	The General Assembly of North Carolina enacts:
5	SECTION 1. Section 30.3F of S.L. 2004-124 reads as rewritten:
6	"SECTION 30.3F. The State of North Carolina shall convey to Currituck County,
7	for consideration of one dollar (\$1.00), forty thousand one dollars (\$40,001), which
8	includes forty thousand dollars (\$40,000) for the legal expenses of the State, title in fee
9	simple absolute with no restrictions or covenants to the land on which the Currituck
10	County Airport is situated all of that certain tract or parcel of land situate, lying and
11	being in Crawford Township, Currituck County, North Carolina, and being more
12	particularly described as follows:
