A BILL TO BE ENTITLED 1 2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A 3 SCUBA SPECIAL REGISTRATION PLATE. 4 The General Assembly of North Carolina enacts: 5 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten: Types. – The Division shall issue the following types of special registration 6 "(b) 7 plates: 8 9

(38a) SCUBA. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 81.12. The plate shall bear the phrase "SCUBA" and a logo of the Diver Down Flag. The Division may not issue the plate authorized by this subdivision unless it receives at least 300 applications for the plate."

**SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

**SECTION 3.** G.S. 20-81.12 is amended by adding a new subsection to read: "(b29) SCUBA. – The Division must receive 300 or more applications for the SCUBA plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Plate Account derived for the sale of the SCUBA plates to the Division of Marine Fisheries for the purpose of developing the State's artificial reefs."

**SECTION 4.** This act is effective when it becomes law.
