SENATE BILL 758

Short Title: UNC/Amend Umstead Act. (Public)

Sponsors: Senator Nesbitt.

1 A BILL TO BE ENTITLED  
2 AN ACT TO AMEND THE UMSTEAD ACT TO BROADEN THE SCOPE OF  
3 ACTIVITIES THAT MAY BE OFFERED BY THE UNIVERSITY OF NORTH  
4 CAROLINA PROVIDED THE ACTIVITIES ARE NOT, IN FACT, UNFAIR  
5 COMPETITION.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 66-58(b)(8) reads as rewritten:

8 "(b) The provisions of subsection (a) of this section shall not apply to:

9 ...

10 (8) The University of North Carolina with regard to:

- 11 a. The University's utilities and other services ~~now operated by~~  
12 ~~it operated by it prior to January 1, 2005.~~
- 13 b. The sale of articles produced incident to the operation of  
14 instructional departments, articles incident to educational  
15 research, articles of merchandise incident to classroom work,  
16 meals, books, or to articles of merchandise ~~not exceeding~~  
17 ~~twenty five cents (25¢) in value~~ when sold to members of the  
18 educational staff or staff auxiliary to education or to duly  
19 enrolled students or occasionally to immediate members of the  
20 families of members of the educational staff or of duly enrolled  
21 students.
- 22 c. The sale of meals or merchandise to persons attending meetings  
23 or conventions as invited guests.
- 24 d. The operation by the University of North Carolina of an inn or  
25 hotel and dining and other facilities usually connected with a  
26 hotel or inn.
- 27 e. The hospital and Medical School of the University of North  
28 Carolina.

- f. The Coliseum of North Carolina State University at Raleigh, and the other schools and colleges for higher education maintained or supported by the State.
- g. The Centennial Campus of North Carolina State University at Raleigh.
- h. The Horace Williams Campus of the University of North Carolina at Chapel Hill.
- i. A Millennial Campus of a constituent institution of The University of North Carolina.
- j. The comprehensive student health services or the comprehensive student infirmaries maintained by the constituent institutions of the University of North Carolina.
- k. Agreements by the North Carolina School of the Arts to the use of that school's facilities, equipment, and services of students, faculty, and staff for the creation of commercial materials and productions that may be unrelated to educational purposes, so long as the proceeds from those agreements are used for the benefit of the educational mission of the North Carolina School of the Arts.

**SECTION 2.** G.S. 66-58 is amended by adding the following new subsections:

"(i) Notwithstanding subsection (a) of this section, nothing in this section shall prohibit The University of North Carolina from engaging in an activity that does any of the following:

- (1) Furthers the mission of the University as stated in G.S. 116-1.
- (2) Primarily serves students, employees, or alumni of the University.
- (3) Enables the community in which a constituent institution or other University entity is located, or the people of the State, to utilize the University's facilities, equipment, or expertise, and the activity is not unfair competition. Whether an activity is unfair competition shall be determined as set out in subsection (j) of this section.

(j) The Board of Governors of The University of North Carolina shall establish a panel to determine whether an activity undertaken pursuant to subdivision (i)(3) of this section is unfair competition with an existing or proposed nongovernmental entity. The panel shall consist of an equal number of members appointed by the Governor who are familiar with the interests of the business community of the State and members appointed by the Board of Governors none of whom may be employees of The University of North Carolina. The panel may make the determination whether a proposed or ongoing activity of The University of North Carolina is unfair competition based on a complaint from any nongovernmental entity in the State that is in or proposes to be in the same or a similar or competing business or based on a request from the constituent institution or other university system entity engaging in or proposing to engage in the activity. The University of North Carolina and its employees

1 may rely on a determination by the panel as to whether an activity violates this section,  
2 and a determination that an activity is not unfair competition and therefore does not  
3 violate this section shall be an absolute defense in any prosecution brought under this  
4 section.

5 (k) The proceeds of any activity undertaken under subsection (i) or subsection (j)  
6 of this section shall be placed in an institutional trust fund pursuant to G.S. 116-36.1 and  
7 shall be used to continue to conduct the activity that generated the proceeds or to further  
8 the mission of the constituent institution or other University entity engaging in the  
9 activity."

10 **SECTION 3.** This act is effective when it becomes law.
