1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE SHARING OF CONFIDENTIAL INFORMATION
3 AMONG AGENCIES OF THE DEPARTMENT OF HEALTH AND HUMAN SERVICES
4 IN ORDER TO CONDUCT QUALITY ASSESSMENT AND IMPROVEMENT
5 ACTIVITIES AND COORDINATE APPROPRIATE AND EFFECTIVE CARE,
6 TREATMENT, OR HABILITATION OF DHHS CLIENTS.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.(a)** G.S. 122C-55(a1) reads as rewritten:

9 "~~(a1) Any State or area facility or the psychiatric service of the University of North~~
10 ~~Carolina Hospitals at Chapel Hill facility~~ may share confidential information regarding any
11 client of that facility with the Secretary, and the Secretary may share confidential information
12 regarding any client with ~~an area or State facility or the psychiatric service of the University of~~
13 ~~North Carolina Hospitals at Chapel Hill~~ a facility when ~~the responsible professional or the~~
14 ~~Secretary determines that disclosure is necessary to~~ conduct quality assessment and
15 improvement activities or to coordinate appropriate and effective care, treatment or habilitation
16 of the client. For purposes of this subsection and subsection (a6) of this section, the purposes or
17 activities for which confidential information may be disclosed include, but are not limited to,
18 case management and care coordination, disease management, outcomes evaluation, the
19 development of clinical guidelines and protocols, the development of care management plans
20 and systems, population-based activities relating to improving or reducing health care costs,
21 and the provision, coordination, or management of mental health, developmental disabilities,
22 and substance abuse services and related services. As used in this section, "Secretary" includes
23 the Department's Community Care of North Carolina Program or other primary care case
24 management programs that contract with the Department to provide a primary care case
25 management program for recipients of publicly funded health and related services."

26 **SECTION 1.(b)** G.S. 122C-55 is amended by adding the following new subsection
27 to read:

28 "(a6) When necessary to conduct quality assessment and improvement activities or to
29 coordinate appropriate and effective care, treatment, or habilitation of the client, a DHHS
30 primary care case manager may disclose confidential information acquired pursuant to
31 subsection (a1) of this section to a health care provider or other entity that has entered into a
32 written agreement with the Department's Community Care of North Carolina Program, or other
33 primary care case management program, to participate in the care management support network
34 and systems developed and maintained by the primary care case manager for the purpose of
35 coordinating and improving the quality of care for recipients of publicly funded health and
36 related services. Health care providers and other entities receiving confidential information
37 from a Department's Community Care of North Carolina Program or other primary care case



1 management program pursuant to this subsection may use and disclose the information as
2 authorized by G.S. 122C-53 through G.S. 122C-56 or as permitted or required by other
3 applicable State or federal law."

4 **SECTION 2.** This act is effective when it becomes law.
