1 A BILL TO BE ENTITLED  
2 AN ACT AMENDING THE MARRIAGE AND FAMILY THERAPY LICENSURE LAWS  
3 AND AUTHORIZING THE NORTH CAROLINA MARRIAGE AND FAMILY  
4 THERAPY LICENSURE BOARD TO INCREASE FEES.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 90-270.47 reads as rewritten:

7 **"§ 90-270.47. Definitions.**

8 As used in this Article, unless the context clearly requires a different meaning:

9 (1) ~~"Allied mental health field" and "degree" mean:~~ Related degree means:

- 10 a. Master's or doctoral degree in clinical social work;  
11 b. Master's or doctoral degree in psychiatric nursing;  
12 c. Master's or doctoral degree in counseling or clinical or counseling  
13 psychology;  
14 d. Doctor of medicine or doctor of osteopathy degree with an  
15 appropriate residency training in psychiatry; or  
16 e. Master's or doctoral degree in any mental health field the course of  
17 study of which is equivalent to the master's degree in marriage and  
18 family therapy.

19 (2) "Board" means the North Carolina Marriage and Family Therapy Licensure  
20 Board.

21 (2a) 'Clinical experience' means face-to-face therapy between a therapist and a  
22 client, whether individuals, couples, families, or groups, conducted from a  
23 larger systems perspective that relates to client treatment plans, is  
24 goal-directed, and assists the client in affecting change cognition and  
25 behavior and effect.

26 (2b) 'Larger systems' means any individual or group that is a part of the client's  
27 environment and that potentially impacts the client's functioning or  
28 well-being and potentially can assist in the development and implementation  
29 of a treatment plan.

30 (3) "Licensed marriage and family therapist" means a person to whom a license  
31 has been issued pursuant to this Article, if the license is in force and not  
32 suspended or revoked.

33 (3a) 'Licensed marriage and family therapy associate' means an individual to  
34 whom a license has been issued pursuant to this Article whose license is in  
35 force and not suspended or revoked and whose license permits the individual

1 to engage in the practice of marriage and family therapy under the  
 2 supervision of an American Association for Marriage and Family Therapy  
 3 (AAMFT) approved supervisor in accordance with rules adopted by the  
 4 Board.

5 ~~(3a)~~(3b) "Marriage and family therapy" is the clinical practice, within the context  
 6 of individual, couple, and marriage and family systems, of the diagnosis and  
 7 treatment of psychosocial aspects of mental and emotional disorders.  
 8 Marriage and family therapy involves the professional application of  
 9 psychotherapeutic and family systems theories and techniques in the  
 10 delivery of services to families, couples, and individuals for the purpose of  
 11 treating these diagnosed mental and emotional disorders. Marriage and  
 12 family therapy includes referrals to and collaboration with ~~other~~ health care  
 13 and other professionals when appropriate.

14 (4) "Practice of marriage and family therapy" means the rendering of  
 15 professional marriage and family therapy services to individuals, couples, or  
 16 families, singly or in groups, whether the services are offered directly to the  
 17 general public or through organizations, either public or private, for a fee,  
 18 monetary or otherwise.

19 (5) "Recognized educational institution" means any educational institution that  
 20 is accredited by the United States Department of Education that grants a  
 21 bachelor's, master's, or doctoral degree and is recognized by the Board and  
 22 by a nationally or regionally recognized educational or professional  
 23 accrediting body."

24 **SECTION 2.** G.S. 90-270.48 reads as rewritten:

25 **"§ 90-270.48. Prohibited acts.**

26 Except as specifically provided elsewhere in this Article, it is unlawful for a person not  
 27 licensed as a marriage and family therapist or as a licensed marriage and family therapy  
 28 associate under this Article to practice marriage or family therapy or hold himself or herself out  
 29 to the public as a person practicing marriage and family therapy."

30 **SECTION 3.** G.S. 90-270.48A reads as rewritten:

31 **"§ 90-270.48A. Exemptions.**

32 (a) This Article does not prevent members of the clergy or licensed, certified, or  
 33 registered members of professional groups recognized by the Board from advertising or  
 34 performing services consistent with their own profession. Members of the clergy include, but  
 35 are not limited to, persons who are ordained, consecrated, commissioned, or endorsed by a  
 36 recognized denomination, church, faith group, or synagogue. Professional groups the Board  
 37 shall recognize include, but are not limited to, licensed or certified social workers, licensed  
 38 professional counselors, fee-based pastoral counselors, licensed practicing psychologists,  
 39 psychological associates, physicians, and attorneys-at-law. However, in no event may a person  
 40 use the title "Licensed Marriage and Family ~~Therapist,~~"Therapist' or "Licensed Marriage and  
 41 Family Therapy Associate," use the letters "LMFT,""LMFT" or "LMFTA," or in any way  
 42 imply that the person is a licensed marriage and family therapist or a licensed marriage and  
 43 family therapy associate unless the person is licensed as such under this Article.

44 (b) A person is exempt from the requirements of this Article if any of the following  
 45 conditions are met:

46 (1) The person is (i) ~~preparing for the practice of marriage and family therapy in~~  
 47 ~~a manner prescribed by rules of the Board,~~enrolled in a master's level  
 48 program or higher in a recognized educational institution, (ii) under qualified  
 49 supervision as approved by the Board in a training institution ~~or facility or~~  
 50 ~~supervisory arrangement recognized and~~ approved by the Board, and (iii)  
 51 designated by a title such as "marriage and family therapy ~~intern,~~" ~~or~~

1 "marriage and family therapy supervisee," or another similar title approved  
2 by the Board.~~intern.~~"

3 (2) The person is practicing marriage and family therapy as an employee of a  
4 recognized educational institution, or a governmental institution or agency  
5 and the practice is included in the duties for which the person was employed  
6 by the institution or agency.

7 ~~(3) The person is practicing marriage and family therapy as an employee of a  
8 nonprofit organization which the Board has determined meets community  
9 needs and the practice is included in the duties for which the person was  
10 employed by the nonprofit organization.~~

11 (4) The person is practicing marriage and family therapy as an employee of a  
12 hospital licensed under Article 5 of Chapter 131E or Article 2 of Chapter  
13 122C of the General Statutes. Provided, however, no such person shall hold  
14 himself out as a licensed marriage and family ~~therapist~~.therapist or licensed  
15 marriage and family therapy associate."

16 **SECTION 4.** G.S. 90-270.49(a) reads as rewritten:

17 "(a) Establishment. – There is established as an agency of the State of North Carolina the  
18 North Carolina Marriage and Family Therapy Licensure Board, which shall be composed of  
19 seven Board members to be appointed as provided in G.S. 90-270.50. Board members shall be  
20 appointed for terms of four years each, except that any person chosen to fill a vacancy shall be  
21 appointed only for the unexpired term of the Board member whom he shall succeed. Upon the  
22 expiration of a Board member's term of office, the Board member shall continue to serve until a  
23 successor has qualified. No person may be appointed more than once to fill an unexpired term  
24 or for more than two consecutive full terms. ~~The Governor shall designate one Board member~~  
25 ~~to serve as chairperson of the Board.~~ The Board shall elect a chair and vice-chair from its  
26 membership to serve a term of four years. No person may serve as chairperson for more than  
27 four years.

28 The Governor may remove any member from the Board or remove the chairperson from the  
29 position of chairperson only for neglect of duty, malfeasance, or conviction of a felony or crime  
30 of moral turpitude while in office.

31 No Board member shall participate in any matter before the Board in which the member has  
32 a pecuniary interest, personal bias, or other similar conflict of interest."

33 **SECTION 5.** G.S. 90-270.51(e) reads as rewritten:

34 "(e) The Board may authorize expenditures to carry out the provisions of this Article  
35 from the fees that it collects, but expenditures may not exceed the revenues or reserves of the  
36 Board during any fiscal year."

37 **SECTION 6.** G.S. 90-270.54 reads as rewritten:

38 "**§ 90-270.54. Requirements for ~~license~~.licensure as a marriage and family therapist.**

39 (a) Each applicant shall be issued a license by the Board to engage in the practice of  
40 marriage and family therapy as a licensed marriage and family therapist if the applicant meets  
41 the qualifications set forth in G.S. 90-270.52(a) and provides satisfactory evidence to the Board  
42 that the applicant:

43 (1) Meets educational and experience qualifications as follows:

44 a. Educational requirements: Possesses a minimum of a master's degree  
45 from a recognized educational institution in the field of marriage and  
46 family therapy, or a related degree ~~in an allied mental health~~  
47 ~~field, degree,~~ which degree is evidenced by the applicant's official  
48 ~~transcripts which establish that the applicant has completed an~~  
49 ~~appropriate course of study in an allied mental health~~  
50 ~~field.~~transcripts. An applicant with a related degree ~~in an allied~~  
51 ~~mental health field~~ may meet the educational requirements if the

1 applicant presents satisfactory evidence of post-master's or  
2 post-doctoral training taken in the field of marriage and family  
3 therapy from a program recognized by the Board regardless whether  
4 the training was taken at a nondegree granting institution or in a  
5 nondegree program, as long as the training, by itself or in  
6 combination with any other training, is the equivalent in content and  
7 quality, as defined in the rules of the Board, of a master's or doctoral  
8 degree in marriage and family therapy;

9 b. Experience requirements: Has at least 1,500 hours of supervised  
10 clinical experience in the practice of marriage and family therapy,  
11 not more than 500 hours of which were obtained while the candidate  
12 was a student in a master's degree program and at least 1,000 of  
13 which were obtained after the applicant was granted a degree in the  
14 field of marriage and family therapy or ~~an allied mental health field~~  
15 related degree (with ongoing supervision consistent with standards  
16 approved by the Board); and

17 (2) Passes an examination ~~administered~~ approved by the Board.

18 (b) Any person who is a certified marriage and family therapist on January 1, 1995,  
19 shall be deemed to be a licensed marriage and family therapist as of that date. Valid and  
20 unexpired certificates operate as licenses for the purposes of this Article until the date set for  
21 renewal of the certificate, at which time the Board shall issue the certificate holder a license in  
22 accordance with G.S. 90-270.58."

23 **SECTION 7.** Article 18C of Chapter 90 of the General Statutes is amended by  
24 adding the following new section to read:

25 "**§ 90-270.54A. Requirements for licensure as a marriage and family therapy associate.**

26 (a) Each applicant shall be issued a license by the Board to engage in practice as a  
27 marriage and family therapy associate if the applicant meets the qualifications set forth in  
28 G.S. 90-270.52(a) and provides satisfactory evidence to the Board that the applicant:

29 (1) Has completed a marriage and therapy degree or related degree in  
30 accordance with G.S. 90-270.54(a)(1)a.

31 (2) Has shown evidence of intent to accrue the required supervised clinical  
32 experience for licensure under G.S. 90-270.54(a)(1)b.

33 (3) Has filed with the Board an application for licensure as a marriage and  
34 family therapy associate, which application includes evidence of the  
35 appropriate coursework and an agreement by at least one supervisor  
36 approved by the American Association of Marriage and Family Therapy to  
37 provide supervision to the applicant.

38 (4) Has passed the examination approved by the Board pursuant to  
39 G.S. 90-270.54(a)(2).

40 (b) Upon approval by the Board, a license designating the applicant as a licensed  
41 marriage and family therapy associate shall be issued. Notwithstanding G.S. 90-270.58, a  
42 license issued under this section shall be valid for three years from the date of issuance.

43 (c) A marriage and family therapy associate license shall not be renewed. However, if  
44 upon written petition to the Board a person licensed pursuant to this section demonstrates  
45 special circumstances and steady progress towards licensure as a marriage and family therapist,  
46 the Board may grant a one-year extension of the marriage and family associate license.

47 (d) Nothing in this Article shall be construed to require direct third-party  
48 reimbursement under private insurance policies to a person licensed as a marriage and family  
49 therapy associate under this Article."

50 **SECTION 8.** G.S. 90-270.55 reads as rewritten:

51 "**§ 90-270.55. Examinations.**

1 The Board shall conduct an examination at least once a year at a time and place designated  
 2 by the Board. ~~Examinations may be written, oral, or both~~ Each applicant for licensure as a  
 3 licensed marriage and family therapist shall pass an examination as determined by the Board.  
 4 ~~Examinations shall include questions in theoretical and applied fields to test an applicant's~~  
 5 ~~knowledge and competence to engage in the practice of marriage and family therapy.~~ The  
 6 Board shall set the passing score for examinations. ~~Any person who fails an examination~~  
 7 ~~conducted by the Board shall not be admitted to a subsequent examination for a period of at~~  
 8 ~~least six months.~~ Any request by an applicant for reasonable accommodations in taking the  
 9 examination shall be submitted in writing to the Board and shall be supported by  
 10 documentation as may be required by the Board in assessing the request."

11 **SECTION 9.** G.S. 90-270.55A is repealed.

12 **SECTION 10.** G.S. 90-270.56 reads as rewritten:

13 **"§ 90-270.56. Reciprocal licenses.**

14 The Board ~~shall~~ may issue a license as a marriage and family therapist or a marriage and  
 15 family therapy associate by reciprocity to any person who applies for the license as prescribed  
 16 by the Board and who is ~~licensed or certified as a marriage and family therapist in another state~~  
 17 ~~whose requirements for the license or certificate are equivalent to or exceed the requirements of~~  
 18 ~~this State.~~ at all times during the application process:

- 19 (1) Has been licensed for five continuous years and is currently licensed as a  
 20 marriage and family therapist or marriage and family therapy associate in  
 21 that state.
- 22 (2) Has an unrestricted license in good standing in the other state.
- 23 (3) Has no unresolved complaints in any jurisdiction.
- 24 (4) Has passed the National Marriage and Family Therapy examination."

25 **SECTION 11.** G.S. 90-270.57 reads as rewritten:

26 **"§ 90-270.57. Fees.**

27 (a) In order to fund the Board's activities under this Article, the Board may charge and  
 28 collect fees not exceeding the following:

29 (1) Each license examination	\$50.00
30 (2) Each license application <del>as a marriage and family therapist</del>	<del>150.00</del> <u>200.00</u>
31 (2a) Each license application <u>as a marriage and family therapy</u> 32 <u>associate</u>	<u>200.00</u>

38 (8) <u>Yearly inactive status maintenance fee</u>	<u>50.00.</u>

39 In addition to the examination fee provided in subdivision (1) of this section, the Board may  
 40 charge and collect from each applicant for license examination the cost of processing test  
 41 results and the cost of test materials.

42 The Board is authorized to return all or a portion of fees paid in cases where the applicant is  
 43 ineligible or in cases of undue hardship.

44 (b) The Board may establish fees for the actual cost of (i) document duplication  
 45 services, (ii) materials, and (iii) returned bank items as allowed by law. All fees listed in  
 46 subsection (a) of this section shall be nonrefundable."

47 **SECTION 12.** G.S. 90-270.58 reads as rewritten:

48 **"§ 90-270.58. Renewal of license.**

49 All licenses for marriage and family therapists issued under this Article shall expire  
 50 automatically on the first day of July of each year. The Board shall renew a license upon (i)

1 completion of the continuing education requirements of G.S. 90-270.58B and (ii) payment of  
2 the renewal fee."

3 **SECTION 13.** G.S. 90-270.58B(a) reads as rewritten:

4 "(a) A person who holds a valid and unexpired license and who is not actively engaged  
5 in the practice of marriage and family therapy may apply to the Board to be placed on inactive  
6 status. A person on inactive status shall not be required to pay annual renewal ~~fees:fees,~~ but  
7 shall be required to pay an annual inactive status maintenance fee. A person who is on inactive  
8 status shall not have to meet continuing education requirements."

9 **SECTION 14.** G.S. 90-270.58C reads as rewritten:

10 **"§ 90-270.58C. Continuing education requirements.**

11 The Board shall prescribe continuing education requirements for licensees. These  
12 requirements shall be designed to maintain and improve the quality of professional services in  
13 marriage and family therapy provided to the public, to keep the licensee knowledgeable of  
14 current research, techniques, and practice, and to provide other resources that will improve skill  
15 and competence in marriage and family therapy. The number of hours of continuing education  
16 shall not exceed the number of hours available that year in Board-approved courses within the  
17 State. The Board may waive these continuing education requirements for not more than 12  
18 months, but only upon the licensee's satisfactory showing to the Board of undue hardship. The  
19 Board may waive, upon request, continuing education requirements for licensees who are on  
20 active military duty and serving overseas."

21 **SECTION 15.** G.S. 90-270.59 reads as rewritten:

22 **"§ 90-270.59. Disposition of funds.**

23 All ~~moneys-monies~~ received by the Board shall be used to implement this Article."

24 **SECTION 16.** G.S. 90-270.60 reads as rewritten:

25 **"§ 90-270.60. Denial, revocation, or suspension of ~~license:license;~~ other disciplinary or**  
26 **remedial actions.**

27 (a) ~~Grounds for Denial, Revocation, or Suspension.~~—The Board may deny, revoke, or  
28 suspend a license granted pursuant to this Article on any of the following grounds:licensure,  
29 discipline, place on probation, limit practice, or require examination, remediation, or  
30 rehabilitation, or any combination of the disciplinary actions described in this subsection, of  
31 any applicant or person licensed under this Article on one or more of the following grounds:

- 32 (1) ~~Conviction of a felony under the laws of the United States or of any state of~~  
33 ~~the United States. Has been convicted of a felony or entered a plea of guilty~~  
34 ~~or nolo contendere to any felony charge under the laws of the United States~~  
35 ~~or of any state of the United States.~~  
36 (2) ~~Conviction of any crime, an essential element of which is dishonesty, deceit,~~  
37 ~~or fraud. Has been convicted of or entered a plea of guilty or nolo contendere~~  
38 ~~to any misdemeanor involving moral turpitude, misrepresentation, or fraud~~  
39 ~~in dealing with the public, or conduct otherwise relevant to fitness to~~  
40 ~~practice marriage and family therapy, or a misdemeanor charge reflecting~~  
41 ~~the inability to practice marriage and family therapy with due regard to the~~  
42 ~~health and safety of clients.~~  
43 (3) ~~Fraud or deceit in obtaining a license as a marriage and family therapist. Has~~  
44 ~~engaged in fraud or deceit in securing or attempting to secure or renew a~~  
45 ~~license under this Article or has willfully concealed from the Board material~~  
46 ~~information in connection with application for a license or renewal of a~~  
47 ~~license under this Article.~~  
48 (4) ~~Dishonesty, fraud or gross negligence in the practice of marriage and family~~  
49 ~~therapy. Has practiced any fraud, deceit, or misrepresentation upon the~~  
50 ~~public, the Board, or any individual in connection with the practice of~~  
51 ~~marriage and family therapy, the offer of professional marriage and family~~

- 1 therapy services, the filing of Medicare, Medicaid, or other claims to any  
2 third-party payor, or in any manner otherwise relevant to fitness for the  
3 practice of marriage and family therapy.
- 4 (5) ~~Violation of any rule of professional ethics and professional conduct adopted~~  
5 ~~by the Board. Has made fraudulent, misleading, or intentionally or~~  
6 ~~materially false statements pertaining to education, licensure, license~~  
7 ~~renewal, supervision, continuing education, any disciplinary actions or~~  
8 ~~sanctions pending or occurring in any other jurisdiction, professional~~  
9 ~~credentials, or qualifications or fitness for the practice of marriage and~~  
10 ~~family therapy to the public, any individual, the Board, or any other~~  
11 ~~organization.~~
- 12 (6) Has had a license or certification for the practice of marriage and family  
13 therapy in any other jurisdiction suspended or revoked, or has been  
14 disciplined by the licensing or certification board in any other jurisdiction  
15 for conduct which would subject him or her to discipline under this Article.
- 16 (7) Has violated any provision of this Article or any rules adopted by the Board.
- 17 (8) Has aided or abetted the unlawful practice of marriage and family therapy by  
18 any person not licensed by the Board.
- 19 (9) Has been guilty of immoral, dishonorable, unprofessional, or unethical  
20 conduct as defined in this subsection or in the current code of ethics of the  
21 American Association for Marriage and Family Therapy. However, if any  
22 provision of the code of ethics is inconsistent and in conflict with the  
23 provisions of this Article, the provisions of this Article shall control.
- 24 (10) Has practiced marriage and family therapy in such a manner as to endanger  
25 the welfare of clients.
- 26 (11) Has demonstrated an inability to practice marriage and family therapy with  
27 reasonable skill and safety by reason of illness, inebriation, misuse of drugs,  
28 narcotics, alcohol, chemicals, or any other substance affecting mental or  
29 physical functioning, or as a result of any mental or physical condition.
- 30 (12) Has practiced marriage and family therapy outside the boundaries of  
31 demonstrated competence or the limitations of education, training, or  
32 supervised experience.
- 33 (13) Has exercised undue influence in such a manner as to exploit the client,  
34 student, supervisee, or trainee for the financial or other personal advantage  
35 or gratification of the marriage and family therapist or a third party.
- 36 (14) Has harassed or abused, sexually or otherwise, a client, student, supervisee,  
37 or trainee.
- 38 (15) Has failed to cooperate with or to respond promptly, completely, and  
39 honestly to the Board, to credentials committees, or to ethics committees of  
40 professional associations, hospitals, or other health care organizations or  
41 educational institutions, when those organizations or entities have  
42 jurisdiction.
- 43 (16) Has refused to appear before the Board after having been ordered to do so in  
44 writing by the chair.
- 45 (b) ~~Any disciplinary action taken shall be in accordance with Chapter 150B of the~~  
46 ~~General Statutes. The Board may, in lieu of denial, suspension, or revocation, take any of the~~  
47 ~~following disciplinary actions:~~
- 48 (1) Issue a formal reprimand or formally censure the applicant or licensee.
- 49 (2) Place the applicant or licensee on probation with the appropriate conditions  
50 on the continued practice of marriage and family therapy deemed advisable  
51 by the Board.

- 1           (3)   Require examination, remediation, or rehabilitation for the applicant or  
2           licensee, including care, counseling, or treatment by a professional or  
3           professionals designated or approved by the Board, the expense to be borne  
4           by the applicant or licensee.
- 5           (4)   Require supervision of the marriage and family therapy services provided by  
6           the applicant or licensee by a licensee designated or approved by the Board,  
7           the expense to be borne by the applicant or licensee.
- 8           (5)   Limit or circumscribe the practice of marriage and family therapy provided  
9           by the applicant or licensee with respect to the extent, nature, or location of  
10          the marriage and family therapy services provided, as deemed advisable by  
11          the Board.
- 12          (6)   Discipline and impose any appropriate combination of the types of  
13          disciplinary action listed in this subsection.

14           In addition, the Board may impose conditions of probation or restrictions on the continued  
15          practice of marriage and family therapy at the conclusion of a period of suspension or as a  
16          requirement for the restoration of a revoked or suspended license. In lieu of or in connection  
17          with any disciplinary proceedings or investigation, the Board may enter into a consent order  
18          relative to discipline, supervision, probation, remediation, rehabilitation, or practice limitation  
19          of a licensee or applicant for a license.

20          (c)   The Board may assess costs of disciplinary action against an applicant or licensee  
21          found to be in violation of this Article.

22          (d)   When considering the issue of whether an applicant or licensee is physically or  
23          mentally capable of practicing marriage and family therapy with reasonable skill and safety  
24          with patients or clients, upon a showing of probable cause to the Board that the applicant or  
25          licensee is not capable of practicing professional counseling with reasonable skill and safety  
26          with patients or clients, the Board may petition a court of competent jurisdiction to order the  
27          applicant or licensee in question to submit to a psychological evaluation by a psychologist to  
28          determine psychological status or a physical evaluation by a physician to determine physical  
29          condition, or both. The psychologist or physician shall be designated by the court. The  
30          expenses of the evaluations shall be borne by the Board. Where the applicant or licensee raises  
31          the issue of mental or physical competence or appeals a decision regarding mental or physical  
32          competence, the applicant or licensee shall be permitted to obtain an evaluation at the applicant  
33          or licensee's expense. If the Board suspects the objectivity or adequacy of the evaluation, the  
34          Board may compel an evaluation by its designated practitioners at its own expense.

35          (e)   Except as provided otherwise in this Article, the procedure for revocation,  
36          suspension, denial, limitations of the license, or other disciplinary, remedial, or rehabilitative  
37          actions, shall be in accordance with the provisions of Chapter 150B of the General Statutes.  
38          The Board is required to provide the opportunity for a hearing under Chapter 150B to any  
39          applicant whose license or health services provider certification is denied or to whom licensure  
40          or health services provider certification is offered subject to any restrictions, probation,  
41          disciplinary action, remediation, or other conditions or limitations, or to any licensee before  
42          revoking, suspending, or restricting a license or health services provider certificate or imposing  
43          any other disciplinary action or remediation. If the applicant or licensee waives the opportunity  
44          for a hearing, the Board's denial, revocation, suspension, or other proposed action becomes  
45          final without a hearing having been conducted. Notwithstanding the provisions of this  
46          subsection, no applicant or licensee is entitled to a hearing for failure to pass an examination. In  
47          any proceeding before the Board, in any record of any hearing before the Board, in any  
48          complaint or notice of charges against any licensee or applicant for licensure, and in any  
49          decision rendered by the Board, the Board may withhold from public disclosure the identity of  
50          any clients who have not consented to the public disclosure of services provided by the licensee  
51          or applicant. The Board may close a hearing to the public and receive in closed session



1 evidence involving or concerning the treatment of or delivery of services to a client who has  
2 not consented to the public disclosure of the treatment or services as may be necessary for the  
3 protection and rights of the client of the accused applicant or licensee and the full presentation  
4 of relevant evidence.

5 (f) All records, papers, and other documents containing information collected and  
6 compiled by or on behalf of the Board, as a result of investigations, inquiries, or interviews  
7 conducted in connection with licensing or disciplinary matters, shall not be considered public  
8 records within the meaning of Chapter 132 of the General Statutes. However, any notice or  
9 statement of charges against any licensee or applicant, or any notice to any licensee or applicant  
10 of a hearing in any proceeding, or any decision rendered in connection with a hearing in any  
11 proceeding, shall be a public record within the meaning of Chapter 132 of the General Statutes,  
12 though the record may contain information collected and compiled as a result of the  
13 investigation, inquiry, or hearing. Any identifying information concerning the treatment of or  
14 delivery of services to a client who has not consented to the public disclosure of the treatment  
15 or services may be redacted. If any record, paper, or other document containing information  
16 collected and compiled by or on behalf of the Board, as provided in this section, is received and  
17 admitted in evidence in any hearing before the Board, it shall be a public record within the  
18 meaning of Chapter 132 of the General Statutes, subject to any deletions of identifying  
19 information concerning the treatment of or delivery of marriage and family therapy services to  
20 a client who has not consented to the public disclosure of treatment or services.

21 (g) A person whose license has been denied or revoked may reapply to the Board for  
22 licensure after one calendar year from the date of the denial or revocation.

23 (h) A licensee may voluntarily relinquish his or her license at any time.  
24 Notwithstanding any provision to the contrary, the Board retains full jurisdiction to investigate  
25 alleged violations of this Article by any person whose license is relinquished under this  
26 subsection and, upon proof of any violation of this Article by the person, the Board may take  
27 disciplinary action as authorized by this section.

28 (i) The Board may adopt rules deemed necessary to interpret and implement this  
29 section."

30 **SECTION 17.** Article 18C of Chapter 90 of the General Statutes is amended by  
31 adding the following new section to read:

32 **"§ 90-270.63. Criminal history record checks of applicants for licensure as a marriage**  
33 **and family therapist and a marriage and family therapy associate.**

34 (a) Definitions. – The following definitions shall apply in this section:

35 (1) Applicant. – A person applying for licensure as a licensed marriage and  
36 family therapy associate pursuant to G.S. 90-270.54A or licensed marriage  
37 and family therapist pursuant to G.S. 90-270.54.

38 (2) Criminal history. – A history of conviction of a State or federal crime,  
39 whether a misdemeanor or felony, that bears on an applicant's fitness for  
40 licensure to practice marriage and family therapy. The crimes include the  
41 criminal offenses set forth in any of the following Articles of Chapter 14 of  
42 the General Statutes: Article 5, Counterfeiting and Issuing Monetary  
43 Substitutes; Article 5A, Endangering Executive and Legislative Officers;  
44 Article 6, Homicide; Article 7A, Rape and Other Sex Offenses; Article 8,  
45 Assaults; Article 10, Kidnapping and Abduction; Article 13, Malicious  
46 Injury or Damage by Use of Explosive or Incendiary Device or Material;  
47 Article 14, Burglary and Other Housebreakings; Article 15, Arson and Other  
48 Burnings; Article 16, Larceny; Article 17, Robbery; Article 18,  
49 Embezzlement; Article 19, False Pretenses and Cheats; Article 19A,  
50 Obtaining Property or Services by False or Fraudulent Use of Credit Device  
51 or Other Means; Article 19B, Financial Transaction Card Crime Act; Article

1 20, Frauds; Article 21, Forgery; Article 26, Offenses Against Public  
2 Morality and Decency; Article 26A, Adult Establishments; Article 27,  
3 Prostitution; Article 28, Perjury; Article 29, Bribery; Article 31, Misconduct  
4 in Public Office; Article 35, Offenses Against the Public Peace; Article 36A,  
5 Riots and Civil Disorders; Article 39, Protection of Minors; Article 40,  
6 Protection of the Family; Article 59, Public Intoxication; and Article 60,  
7 Computer-Related Crime. The crimes also include possession or sale of  
8 drugs in violation of the North Carolina Controlled Substances Act in Article  
9 5 of Chapter 90 of the General Statutes and alcohol-related offenses  
10 including sale to underage persons in violation of G.S. 18B-302 or driving  
11 while impaired in violation of G.S. 20-138.1 through G.S. 20-138.5. In  
12 addition to the North Carolina crimes listed in this subdivision, such crimes  
13 also include similar crimes under federal law or under the laws of other  
14 states.

15 (b) The Board may request that an applicant for licensure, an applicant seeking  
16 reinstatement of a license, or a licensee under investigation by the Board for alleged criminal  
17 offenses in violation of this Article consent to a criminal history record check. Refusal to  
18 consent to a criminal history record check may constitute grounds for the Board to deny  
19 licensure to an applicant, deny reinstatement of a license to an applicant, or revoke the license  
20 of a licensee. The Board shall ensure that the State and national criminal history of an applicant  
21 is checked. The Board shall be responsible for providing to the North Carolina Department of  
22 Justice the fingerprints of the applicant or licensee to be checked, a form signed by the  
23 applicant or licensee consenting to the criminal record check and the use of fingerprints and  
24 other identifying information required by the State or National Repositories of Criminal  
25 Histories, and any additional information required by the Department of Justice in accordance  
26 with G.S. 114-19.26. The Board shall keep all information obtained pursuant to this section  
27 confidential. The Board shall collect any fees required by the Department of Justice and shall  
28 remit the fees to the Department of Justice for expenses associated with conducting the criminal  
29 history record check.

30 (c) If an applicant or licensee's criminal history record check reveals one or more  
31 convictions listed under subdivision (a)(2) of this section, the conviction shall not automatically  
32 bar licensure. The Board shall consider all of the following factors regarding the conviction:

- 33 (1) The level of seriousness of the crime.
- 34 (2) The date of the crime.
- 35 (3) The age of the person at the time of the conviction.
- 36 (4) The circumstances surrounding the commission of the crime, if known.
- 37 (5) The nexus between the criminal conduct of the person and the job duties of  
38 the position to be filled.
- 39 (6) The person's prison, jail, probation, parole, rehabilitation, and employment  
40 records since the date the crime was committed.
- 41 (7) The subsequent commission by the person of a crime listed in subdivision  
42 (a)(2) of this section.

43 If, after reviewing these factors, the Board determines that the applicant or licensee's criminal  
44 history disqualifies the applicant or licensee for licensure, the Board may deny licensure or  
45 reinstatement of the license of the applicant or revoke the license of the licensee. The Board  
46 may disclose to the applicant or licensee information contained in the criminal history record  
47 check that is relevant to the denial. The Board shall not provide a copy of the criminal history  
48 record check to the applicant or licensee. The applicant or licensee shall have the right to  
49 appear before the Board to appeal the Board's decision. However, an appearance before the full  
50 Board shall constitute an exhaustion of administrative remedies in accordance with Chapter  
51 150B of the General Statutes.

1       (d) Limited Immunity. – The Board, its officers, and employees, acting in good faith  
2 and in compliance with this section, shall be immune from civil liability for denying licensure  
3 or reinstatement of a license to an applicant or revoking a licensee's license based on  
4 information provided in the applicant or licensee's criminal history record check."

5       **SECTION 18.** Article 4 of Chapter 114 of the General Statutes is amended by  
6 adding a new section to read:

7 **"§ 114-26. Criminal history record checks of applicants for licensure as marriage and**  
8 **family therapists and marriage and family therapy associates.**

9       The Department of Justice may provide to the North Carolina Marriage and Family  
10 Therapy Licensure Board from the State and National Repositories of Criminal Histories the  
11 criminal history of any applicant for licensure or reinstatement of a license or licensee under  
12 Article 18C of Chapter 90 of the General Statutes. Along with the request, the Board shall  
13 provide to the Department of Justice the fingerprints of the applicant or licensee, a form signed  
14 by the applicant or licensee consenting to the criminal record check and use of fingerprints and  
15 other identifying information required by the State and National Repositories, and any  
16 additional information required by the Department of Justice. The applicant or licensee's  
17 fingerprints shall be forwarded to the State Bureau of Investigation for a search of the State's  
18 criminal history record file, and the State Bureau of Investigation shall forward a set of  
19 fingerprints to the Federal Bureau of Investigation for a national criminal history record check.  
20 The Board shall keep all information obtained pursuant to this section confidential. The  
21 Department of Justice may charge a fee to offset the cost incurred by the Department to  
22 conduct a criminal record check under this section. The fee shall not exceed the actual cost of  
23 locating, editing, researching, and retrieving the information."

24       **SECTION 19.** This act is effective when it becomes law.
