11	(a) <u>The Joint Legislative Oversight Committee on General Government is established.</u>

13	(1) Six members of the Senate appointed by the President Pro Tempore of the

15	(2) Six members of the House of Representatives appointed by the Speaker of

17	(b) Terms on the Committee are for two years and begin on the convening of the					
18 19	General Assembly in each odd-numbered year. Members may complete a term of service on the Committee even if they do not each realization or are not realized to the Concerel Assembly.

29	has the following powers and duties:
